

# Do you Need a Lawyer to Help with your Case?

## You May have the Right to an Attorney Paid for by the State if You Are:

Charged with a crime (as an adult or a juvenile)  
A Juvenile subject of an At-Risk Youth or Child in Need of Services Petition  
A child or parent involved in a dependency or shelter care proceeding

Contact the Office of Assigned Counsel at (360) 416-1690 to see if you qualify for a lawyer to represent you.

### Family Law and Guardianship Cases

The services of a Courthouse Facilitator (CHF) are available for help with some family law matters (dissolutions or divorce, paternity, non-parental custody) and guardianships. You need to make an appointment by calling (360) 416-1219 or (360) 416-1200. If you are representing yourself on a family law case, you must meet with a courthouse facilitator to review final orders you plan to file with the court.
