#### 2 VOTER REGISTRATION INFORMATION

#### QUALIFICATION FOR VOTING

In order to become a registered voter, a person must be:

- A United States citizen
- A resident of the State of Washington for 30 days immediately preceding the day of election
- 18 years old on or before the day of election
- Not presently denied civil rights as a result of felony conviction

#### WHEN TO REGISTER

Register at anytime. However, registration files close 30 days prior to an election for voting at a polling place on Election Day. Mail-in registration forms must be postmarked no later than the 30-day closing date in order to be eligible to vote at a polling place on Election Day.

Persons who do not register by the 30-day deadline may register <u>in person</u> at the Skagit County Auditor's Office during a special registration period between the 30th day and the 15th day prior to an election. Persons registering during the special period may only vote by absentee ballot for that election.

#### **REGISTRATION DEADLINES**

November 2, 2004 General Election

30 day deadline = October 2, 2004 15 day deadline = October 18, 2004

#### WHERE TO REGISTER

Registration can be done either in person or by obtaining a mail-in registration form from any of the following locations:

- Skagit County Auditor's Office
- Cascade Mall Information Desk
- Chambers of Commerce
- City/Town Halls
- Post Offices
- Public Libraries
- Public Schools
- Senior Service Centers
- State Agencies including Department of Motor Vehicles
- Vehicle Licensing Offices

In addition, a registration form can be downloaded on line at www.secstate.wa.gov or requested by calling the Skagit County Elections Department at (360) 336-9305.

#### WHEN TO TRANSFER

When moving from one address to another within Skagit County, the new address must be reported to the Elections Department at least 30 days before the next election. Contact the Elections Department by phone at (360) 336-9305, by mail, or in person. A new registration card showing new precinct and voting location will be issued and mailed. If moving from another county or state, a new registration form must be completed.

#### NAME CHANGE

In order to change a name in voting records, a new registration form must be completed with the new signature. This can be done using the mail-in voter registration form obtained at any of the locations shown above.

#### WHERE TO VOTE

Upon registering to vote or transferring, voters are sent a registration card listing their assigned precinct and polling place. Polling places also appear in local newspapers the Wednesday prior to an election. If you have any questions regarding where you vote, please call the election department.

#### **VOTER REGISTRATION CARDS**

Skagit County registration cards are not a form of identification and they are not proof of United State Citizenship as per Public Law 104-99. Voters are not required to show their registration card in order to vote. If you would like a replacement card, please notify the Skagit County Elections Department.

#### 3 ABSENTEE BALLOT INFORMATION

#### WHO CAN APPLY?

Any Skagit County registered voter or any out-of-state, overseas, or service voter may vote by absentee ballot in any general election, special election, or primary.

#### **HOW TO OBTAIN AN ABSENTEE BALLOT?**

A regular absentee ballot may be requested in person, by telephone, or by written request. Applicants for ongoing absentee status must apply in writing. Ballots may be requested no earlier than 90 days prior to an election and no later than the day before the election. Ballots are available over the counter at the Auditor's Office 20 days before an election. The date ballots will be available for the General Election is October 13, 2004. Either the voter or a voter's immediate family member can make an application for an absentee ballot.

The following information should be included:

- Name as registered
- Address at which the voter is currently registered to vote
- Address to which the ballot should be mailed
- Birth date for verification purposes

#### **REGULAR ABSENTEE BALLOTS**

The first day to obtain an absentee ballot for the General Election on November 2 is October 13. Regular absentee ballots can be requested up until the day before the election.

#### ONGOING ABSENTEE BALLOTS

Registered voters who wish to receive an absentee ballot on a permanent (ongoing) basis can apply in writing by filling out a request form. These forms can be requested from the Auditor's Office at any time. A permanent, year-round mailing address is required. Ongoing absentee voters will automatically be mailed an absentee ballot for any election in which they are entitled to vote.

#### ABSENTEE VOTING WHILE IN A HOSPITAL

Registered voters who are hospitalized can receive an absentee ballot up to and on the day of the election. Please contact the Election Department to receive a ballot.

#### SPECIAL ABSENTEE BALLOT (SUBMARINE BALLOTS)

Any registered voter who completes an application stating that he or she is unable to vote and return an absentee ballot by normal mail delivery within

the period provided for by regular absentee ballot may request a special absentee ballot (submarine ballot).

## SKAGIT COUNTY FIRE PROTECTION DISTRICT NO. 17 PROPOSITION NO. 1

#### **AUTHORIZING REGULAR PROPERTY TAX LEVY INCREASE**

The Board of Fire Commissioners of Fire Protection District No. 17, Skagit County, Washington, adopted Resolution No. 218 authorizing a regular property tax levy of\$0.50 per \$1,000. This proposition would authorize the District to set and maintain a regular property tax levy of \$0.50 per \$1,000 of assessed valuation for 2005 and for the five (5) years thereafter pursuant to RCW 84.55.050 and subject to any otherwise applicable statutory dollar rate limitations. #### **EXPLANATORY STATEMENT**

This proposition would authorize the District to set and maintain a regular property tax levy of \$0.50 per \$1,000 of assessed valuation for 2005 and five years thereafter pursuant to RCW 84.55.050.
