MOUNT VERNON SCHOOL DISTRICT NO. 320
GENERAL OBLIGATION BONDS - \$46,400,000

The Board of Directors of Mount Vernon School District #320 adopted Resolution #04/06-07 concerning this proposition for bonds. This proposition authorizes the District to rebuild Madison Elementary School, construct and equip a new elementary school, modernize and add classroom space to Mount Vernon High School and its gymnasium and field house complex and make other capital improvements to District facilities, to issue \$46,400,000 of general obligation bonds maturing within a maximum term of 20 years, and to levy excess property taxes annually to repay the bonds, all as described in District Resolution #04/06-07. PROPOSITION NO. 1
ANACORTES SCHOOL DISTRICT NO. 103
GENERAL OBLIGATION BONDS - \$59,800,000

The Board of Directors of Anacortes School District No. 103 approved Resolution No. 714 concerning this proposition for bonds. This proposition authorizes the District to modernize and expand Anacortes High School and Mount Erie Elementary School, construct a new maintenance facility, acquire land, and make other capital improvements; to issue \$59,800,000 of general obligation bonds maturing within a maximum term of 20 years, and to levy excess property taxes annually to repay the bonds, as described in Resolution #714. BURLINGTON-EDISON SCHOOL DISTRICT NO. 100
GENERAL OBLIGATION BONDS - \$59,700,000

The Board of Directors of Burlington-Edison School District No. 100 approved Resolution #733 concerning this proposition for bonds. This proposition authorizes the District to modernize Burlington-Edison High School and West View Elementary, construct and equip a new elementary school, acquire land, refinance existing bonds and make other capital improvements; to issue \$59,700,000 of general obligation bonds maturing within a maximum term of 20 years; and to levy excess property taxes annually to repay the bonds, as described in Resolution #733. PROPOSITION NO. 1

SEDRO-WOOLLEY SCHOOL DISTRICT NO. 101
GENERAL OBLIGATION BONDS - \$45,000,000

The Board of Directors of Sedro-Woolley School District No. 101 adopted Resolution #813 concerning this proposition for bonds. This proposition authorizes the District to construct a new middle school, modernize Evergreen Elementary, add additional classrooms at Big Lake and Mary Purcell Elementaries, construct a covered commons area at Sedro-Woolley High School, construct new activity sheds and make other capital improvements to District facilities, issue \$45,000,000 of general obligation bonds maturing within a maximum term of 20 years, and levy excess property taxes annually to repay the bonds, described in District Resolution #813.
