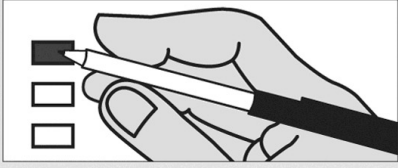

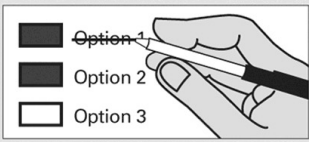
How to vote
