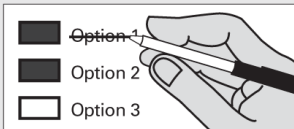

#### How to vote



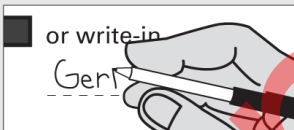
Use a dark blue or black ink pen to completely fill in the box to the left of your choice.

**Skagit County Public Hospital District No. 2**  
**Proposition No. 1**  
**Levy for Healthcare facility**

The Board of Commissioners of Skagit County Public Hospital District No. 2 adopted Resolution No. 2017-2048, concerning an increase in the District's regular property tax levy. If approved, this proposition would authorize a maximum regular property tax levy rate for collection in 2018 of 50 cents per \$1000 of assessed value (which is approximately 31 cents greater than the 2017 levy rate). The 2018 levy amount would become the base for computing the limitations for future levies.
