Meeting called to order at 1:30 PM by Perkins.

Canvassing board reviews minutes/challenged ballots list from 11/21 canvassing meeting last week, as well as meeting minutes from certification for August  $1^{st}$  2023 Primary Election. D'Avignon moves to approve both sets of minutes. All in favor; none opposed. Motion passes unanimously.

D'Avignon issues Oath of Authenticity to Perkins, witnessed by D'Avignon and Wesen.

Canvassing board reviews Nov 7, 2023 General Election reconciliation report, as well as recount contest for Sedro-Woolley School District, Director District 2.

Perkins moves to accept reconciliation report for Nov 7, 2023 General Election. D'Avignon seconds. All in favor; none opposed. Motion passes unanimously.

Perkins moves to reject all challenged ballots; D'Avignon seconds. All in favor; none opposed. Motion passes unanimously.

Perkins moves to accept reports and certify election; D'Avignon seconds. All in favor; none opposed. Motion passes unanimously.

Must be under 200 vote difference and under a quarter percent difference for a manual hand recount. Recount threshold passed in Sedro-Woolley School District, Director District 2; manual recount required. Ballot preparation and precincting to start tomorrow, Wednesday 11/29/2023; recount will be held on Monday 12/4/2023 with re-certification scheduled for following Monday, 12/11/2023.

Canvassing board signs authorization/delegation for Elections Department to begin recount process.

Wesen signs delegation for someone else to attend the 12/11/2023 re-certification meeting in his stead.

## **Public Comment:**

**Bill Bruch**: Confirms candidates having recount in S-W School District. Clay confirms Mullen Doyle leads Jepperson by six votes. Monday is manual hand recount, potentially taking 2 - 2½ days to complete.

No other public comments. No further business.
