

## **Proposition No. 1**

Property Tax Levy for Fire Protection and Emergency Medical Services

The Board of Skagit County Fire Protection District No. 17 adopted Resolution No. 469 concerning a proposition to maintain and adequately fund District operations. This proposition would authorize the District to restore its 2024 regular property tax levy to \$.50 per \$1,000.00 of assessed valuation (collected in 2025) with adjustments by the greater of 1% or the annual CPI-W for Seattle-Tacoma-Bellevue as reported in June of the levy year for each of the five succeeding years. The maximum allowable levy in the final year shall serve as the base for subsequent levy limitations as provided by Chapter 84.55 RCW.
