Background

Registered voter ERIN LYNN ADAMS, DOB 1 June 1980, (the "VOTER") is registered with a residence address of 246 OLD HIGHWAY 99 N ROAD, BELLINGHAM WA 98229 and a status of Active. There is no separate mailing address on file for the VOTER in the Voter Registration Database ("VRDB").

History

The Washington Voter Research Project canvassed this address on 15 June 2023. At the time, the canvasser learned the VOTER did not reside at the residence address listed in the VRDB.

Letter

On 17 June 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form.

Envelope

On or about 12 July 2024, the letter to the residence address in the VRDB was returned to me marked "Return To Sender – Not Deliverable As Addressed – Unable to Forward".

There is no *landline* phone number with a 360-area code.

Data obtained from this source on 19 August 2024 shows a Erin Adams with an age consistent with the birthyear listed in the VRDB at the address of 6800 Wakefield Avenue, Cleveland OH 44102. There are addresses in Ohio, Minnesota, South Dakota and Florida as well as a single address in Washington state –the residence address listed in the VRDB. There is no *landline* phone number with a 360-area code.

A Skagit County Property Search conducted on 19 August 2024 shows that there is no real property in Skagit County owned in the name Erin Adams.

Source 4: Washington State Secretary of State https://voter.votewa.gov/

As of 1 August 2024, the Washington State Secretary of State website (containing voter registration data of Washington State registered voters) shows Erin Lynn Adams with a birthyear of 1980 with a residence address of 246 Old Highway 99 N Road, Bellingham WA last voted on 2 November 2021.

The VoteRef website, containing the voter registration databases of at least 30 states, shows a number of other voters registered with the name Erin Lynn Adams, however no birthdate/birthyear data is available.

Conclusion

A canvasser learned ERIN LYNN ADAMS does not currently reside at 246 OLD HIGHWAY 99 N ROAD, BELLINGHAM WA. The data indicates that the voter does not own property in Skagit County, has no *landline* phone number in Skagit County, and may be registered to vote in several of the 30+ states covered by VoteRef. The letter to the voter posted to the residence address was returned marked "Return To Sender – Not Deliverable As Addressed - Unable to Forward".

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed from the roll.
