ROBERT E. AVALOS – WA4140377: Voter Challenge Summary

Background

Registered voter ROBERT E. AVALOS, DOB 14 November 1971, (the "VOTER") is registered with a residence address of 180 ALDERSON PLACE, BURLINGTON WA 98233 and a status of Active. There is no separate mailing address on file for the VOTER in the Voter Registration Database ("VRDB").

History

The Washington Voter Research Project canvassed this address on 15 April 2024. At the time, the canvasser learned the VOTER did not reside at the residence address listed in the VRDB. The VOTER is the brother-in-law of the resident, who advised the VOTER had moved to California.

Letter

On 30 May 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form.

On or about 18 June 2024, the letter to the residence address in the VRDB was returned to me marked "Return To Sender – Unclaimed – Unable to Forward".

Conclusion

A canvasser learned that ROBERT E. AVALOS does not currently reside at 180 ALDERSON PLACE, BURLINGTON WA. The data indicates that the voter does not own property in Skagit County, has (or had) a *landline* phone number with a 360-area code, and is not registered to vote in Idaho. The letter to the voter posted to the residence address was returned marked "Return To Sender – Unclaimed - Unable to Forward".

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed from the roll.






