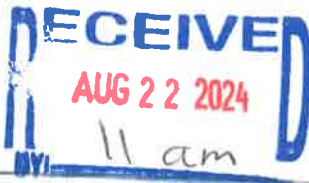

Background

Registered voter NICHOLAS DANIEL BENZ, DOB 28 June 1974, (the "VOTER") is registered with a residence address of 14791 TAGGERT QUARRY RD, ANACORTES WA 98221 and a status of Active. There is a separate mailing address on file for the VOTER in the Voter Registration Database ("VRDB") of 1121 Harrison Ave #5033, Centralia WA 98531.

History

The Washington Voter Research Project developed evidence and information that the VOTER did not reside at the residence address listed in the VRDB. The Ballot Status Report issued by the Washington state Secretary of State for the November 2022 federal general election was examined to determine if the VOTER received an early (UOCAVA) ballot. The report does not reflect an early ballot send date, rather a send date consistent with the general voting population.

Letter(s)

On 8 July 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form. A copy of the letter was mailed to the separate address on file in the VRDB.

Envelope

On or about 1 August 2024, the letter to the residence address in the VRDB was returned to me marked "Return To Sender – Unclaimed – Unable to Forward".

Data obtained from this source on 22 August 2024 shows a Nicholas Benz with an age consistent with the birthyear listed in the VRDB at the address of 1121 Harrison Ave Unit 5033, Centralia WA 98531. There are no other addresses in Washington state, rather only multiple addresses in California. There is no *landline* phone number with a 360-area code.

Data obtained from this source on 22 August 2024 shows a Nicholas Benz with an age consistent with the birthyear listed in the VRDB at the address of 2203 Sea Shell Drive, Richmond CA 94804. There are no addresses in Washington state. There are multiple addresses in California and an address in Florida. There is no *landline* phone number with a 360-area code.

A Skagit County Property Search conducted on 22 August 2024 shows that there is no real property in Skagit County owned in the name Nicholas Benz.

As of 1 August 2024, the Washington State Secretary of State website (containing voter registration data of Washington State registered voters) shows Nicholas Daniel Benz with a birthyear of 1974 with a residence address of 14791 Taggart Quarry Road, Anacortes WA last voted on 8 November 2022.



Conclusion

Evidence and information was developed that NICHOLAS DANIEL BENZ does not currently reside at 14791 TAGGERT QUARRY ROAD, ANACORTES WA. The data indicates that the voter does not own property in Skagit County, has no *landline* phone number in Skagit County, and is not registered to vote in the 30+ states covered by VoteRef. The letter to the voter posted to the residence address was returned marked "Return To Sender – Unclaimed - Unable to Forward".

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed from the roll.



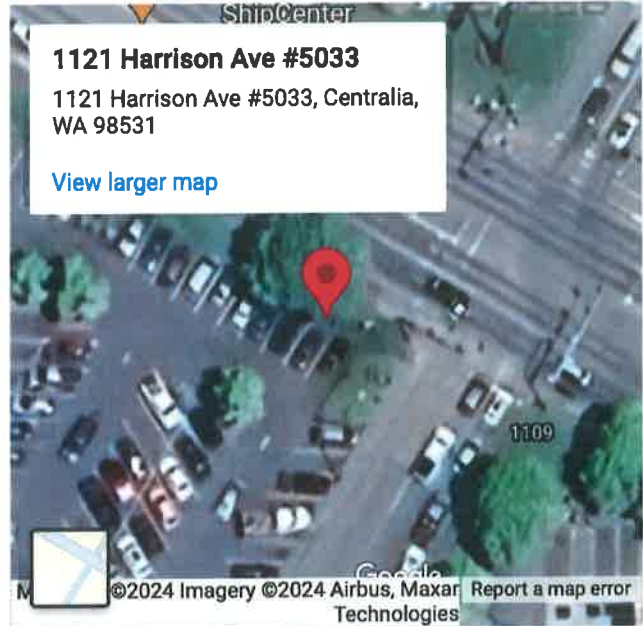

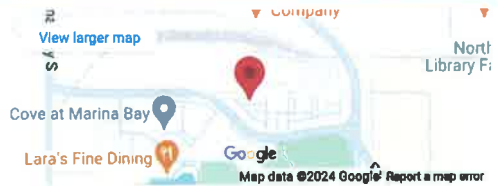
