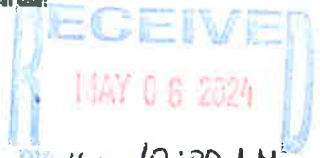

THEODORE THOMAS BROWN – WA11354729: Voter Challenge Summary

Background

Registered voter THEODORE THOMAS BROWN, DOB 3 September 1957, (the "VOTER") is registered with a residence address of 3410 APACHE DR, MOUNT VERNON WA 98273 and a status of Active. There is a separate mailing address on file for the VOTER in the Voter Registration Database ("VRDB") of 1777 S Burlington Blvd PMB215, Burlington WA 98233.

History

The Washington Voter Research Project canvassed this address on 3 February 2024. At the time, the canvasser learned the VOTER did not reside at the residence address listed in the VRDB.

Affidavit

On 3 February 2024, an affidavit was collected from affiant ANDREW BLACKSTONE, certifying that the VOTER does not reside at the address.

Letter(s)

On 6 February 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form. A copy of the letter was mailed to the separate address on file in the VRDB.

Envelope

On or about 15 February 2024, the letter to the residence address in the VRDB was returned to me marked "Return To Sender – Not Deliverable As Addressed – Unable to Forward".

Data obtained from this source on 25 April 2024 shows a Theodore Brown with an age consistent with the birthdate listed in the VRDB at the address of 19163 W Big Lake Blvd, Mount Vernon WA 98274. There are multiple additional addresses in Washington state, none being the residence address listed in the VRDB, as well as addresses in Alaska. There is no *landline* phone number with a 360-area code, a code incorporating Skagit County.

Data obtained from this source on 25 April 2024 shows a Theodore Brown with an age consistent with the birthdate listed in the VRDB at the address of 19163 W Big Lake Blvd, Mount Vernon WA 98274. There are multiple additional addresses in Washington state, none being the residence address listed in the VRDB, as well as addresses in Alaska. There is no *landline* phone number with a 360-area code, a code incorporating Skagit County.

A Skagit County Property Search conducted on 25 April 2024 shows that there is no real property in Skagit County owned in the name Theodore Brown.


As of 25 April 2024, the Federal Bureau of Prisons Inmate Locator shows no federal incarceration for anyone named Theodore Brown.

Conclusion

An affidavit was obtained attesting that THEODORE THOMAS BROWN does not currently reside at 3410 APACHE DR, MOUNT VERNON, WA. The data indicates that the voter does not own property in Skagit County, has no *landline* phone number in Skagit County, and is not registered to vote in the 30+ states covered by VoteRef. The letter to the voter posted to the residence address was returned marked "Return To Sender – Not Deliverable As Addressed - Unable to Forward".

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed.

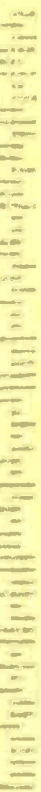

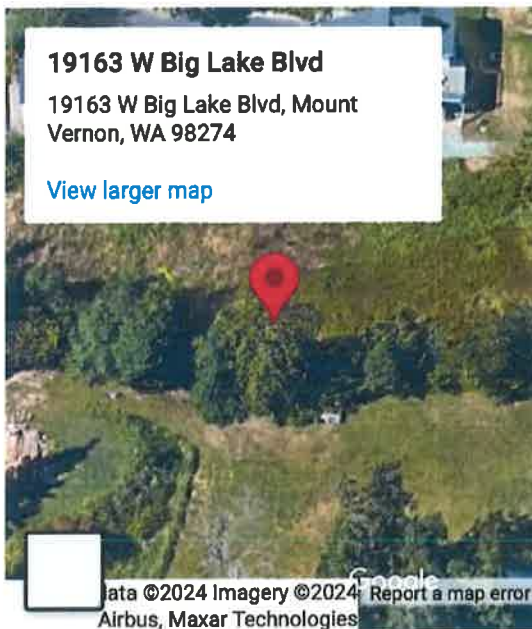

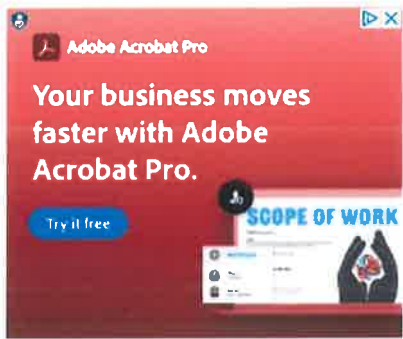
