MELISSA DANIELLE BROWNING – WA10659287: Voter Challenge Summary

Background

Registered voter MELISSA DANIELLE BROWNING, DOB 5 September 1996, (the “VOTER”) is registered with a residence address of 5409 N DARRK LN, BOW WA 98232 and a status of Active. There is a separate mailing address on file for the VOTER in the Voter Registration Database (“VRDB”) of P.O. Box 154, Burlington WA 98233.

History

The Washington Voter Research Project canvassed this address on 16 June 2023. At the time, the canvasser learned the VOTER did not reside at the residence address listed in the VRDB.

Affidavit

On 16 June 2023, an affidavit was collected from affiant TINA FORD, certifying that the VOTER does not reside at the address.

Letter(s)

On 28 November 2023, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form. A copy of the letter was mailed to the separate mailing address in the VRDB.

Envelope

On or about 30 November 2023, the letter to the residence address was “Left With An Individual” according to the US Postal Service. It should be noted 5409 N Darrk Ln in Bow WA is Thousand Trails, a large “check-in/check-out” camping park.

Data obtained from this source on 27 April 2024 shows a Melissa Browning with an age consistent with the birthyear listed in the VRDB at the address of 516 High St RM404, Bellingham WA 98225. There are two additional addresses in Washington state, not including the residence address listed in the VRDB. There is no *landline* phone number with a 360-area code.

A Skagit County Property Search conducted on 27 April 2024 shows that there is no real property in Skagit County owned in the name Melissa Browning.

As of 1 April 2024, the Washington State Secretary of State website (containing voter registration data of Washington State registered voters) shows melissa Danielle Browning with a birthyear of 1996 with a residence address of 5409 N Darrk Ln, Bow WA last voted on 3 November 2020.



Conclusion

An affidavit was obtained attesting that MELISSA DANIELLE BROWNING does not currently reside at 5409 N DARRK LN, BOW WA. The data indicates that the voter does not own property in Skagit County, has no *landline* phone number in Skagit County, and is not registered to vote in the 30+ states covered by VoteRef. The letter to the voter posted to the residence address was “Left With An Individual” according to the US Postal Service.

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed.

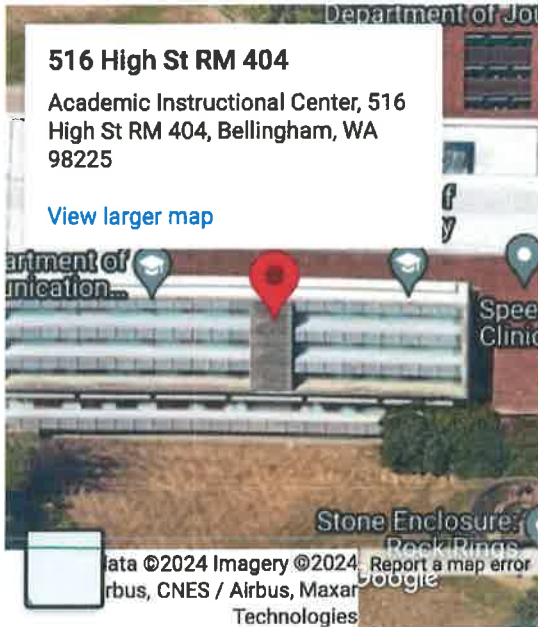
