MICHAEL LEE COOK – WA3179475: Voter Challenge Summary

Background

Registered voter MICHAEL LEE COOK, DOB 11 March 1964, (the "VOTER") is registered with a residence address of 1938 S 6TH STREET UNIT B, MOUNT VERNON WA 98273 and a status of Active. There is a separate mailing address on file for the VOTER in the Voter Registration Database ("VRDB") of 13616 56th Ave SE, Everett WA 98208.

History

The Washington Voter Research Project canvassed this address on 9 June 2024. At the time, the canvasser learned the VOTER did not reside at the residence address listed in the VRDB. The residence address is a duplex. The canvasser spoke with the neighboring occupant of Unit A, who indicated the VOTER had moved from the residence years ago.

Letter(s)

On 10 June 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form. A copy of the letter was mailed to the separate address on file for in the VRDB.

Envelope

On or about 13 June 2024, the letter to the residence address in the VRDB was returned to me marked "Return To Sender – Not Deliverable As Addressed – Unable to Forward".

A Skagit County Property Search conducted on 21 August 2024 shows a real property in Skagit County owned in the name Michael F. Cook at 4117 Kingsway, Anacortes WA. The Washington State Secretary of State website shows a Michael F. Cook with a birthyear of 1947 registered to vote at that address. There is no real property in Skagit County owned in the name Michael Lee Cook or otherwise in the name Michael Cook generally.

As of 1 August 2024, the Washington State Secretary of State website (containing voter registration data of Washington State registered voters) shows Michael Lee Cook with a birthyear of 1964 with a residence address of 1938 S 6th Street Unit B, Mount Vernon WA last voted on 3 November 2020.

The VoteRef website, containing the voter registration databases of at least 30 states, shows multiple other voters registered across multiple other states with the name Michael Lee Cook either having an age consistent with the VOTER's age as set out in the VRDB or without available birthdate/birthyear data.

As of 21 August 2024, the Skagit County Jail Roster search shows no current inmates with the name of Michael Cook.


As of 21 August 2024, the Federal Bureau of Prisons Inmate Locator shows prior federal incarcerations for two individuals named Michael Lee Cook with ages inconsistent with the age of the VOTER as set out in the VRDB.

Conclusion

A canvasser learned that MICHAEL LEE COOK does not currently reside at 1938 S 6TH STREET UNIT B, MOUNT VERNON WA. The data indicates that the voter does not own property in Skagit County, has no *landline* phone number in Skagit County, and may potentially be registered to vote in one or more of the 30+ states covered by VoteRef. The letter to the voter posted to the residence address was returned marked "Return To Sender – Not Deliverable As Addressed - Unable to Forward".

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed from the roll.
