JUSTIN ROBERT CROUCH – WA12739495: Voter Challenge Summary

Background

Registered voter JUSTIN ROBERT CROUCH, DOB 25 June 1974, (the “VOTER”) is registered with a residence address of 20599 STATE ROUTE 534, MOUNT VERNON WA 98274 and a status of Active. There is no separate mailing address on file for the VOTER in the Voter Registration Database (“VRDB”).

History

The Washington Voter Research Project canvassed this address on 28 July 2023, and thereafter attended the property periodically in the Fall of 2023. The canvasser adjudged the property to be derelict and appearing abandoned.

Letter

On 17 June 2024, I mailed a letter via USPS Certified Mail (Return Receipt Requested) to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form.

Envelope

On or about 20 June 2024, I received back the Return Receipt marked as received by an “Agent” appearing to be the USPS. No signature appeared thereon.

Data obtained from this source on 20 June 2024 shows a Justin crouch with an age consistent with the birthyear listed in the VRDB at the address of 12613 NE 192nd Place, Bothell WA 98011. There are multiple additional addresses in Washington state, none of which is the residence address listed in the VRDB. There is no *landline* phone number with a 360-area code.

Data obtained from this source on 20 June 2024 shows a Justin crouch with an age consistent with the birthyear listed in the VRDB at the address of 12613 NE 192nd Place, Bothell WA 98011. There are multiple additional addresses in Washington state, none of which is the residence address listed in the VRDB, and one address in Montana. There is no *landline* phone number with a 360-area code.

A Skagit County Property Search conducted on 20 June 2024 shows that there is no real property in Skagit County owned in the name Justin Crouch.

As of 1 June 2024, the Washington State Secretary of State website (containing voter registration data of Washington State registered voters) shows Justin Robert Crouch with a birthyear of 1974 with a residence address of 20599 State Route 534, Mount Vernon WA last voted on 3 November 2020.


As of 20 June 2024, the Federal Bureau of Prisons Inmate Locator shows no federal incarceration for anyone named Justin Crouch.

Conclusion

A canvasser attended the VOTER's residence address on multiple occasions, adjudging the property as derelict and appearing abandoned. The data indicates that the voter does not own property in Skagit County, has no *landline* phone number in Skagit County, and is not registered to vote in Idaho. The letter to the voter posted to the residence address on a Return Receipt basis was not returned signed by the VOTER (or by anyone for that matter).

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed.

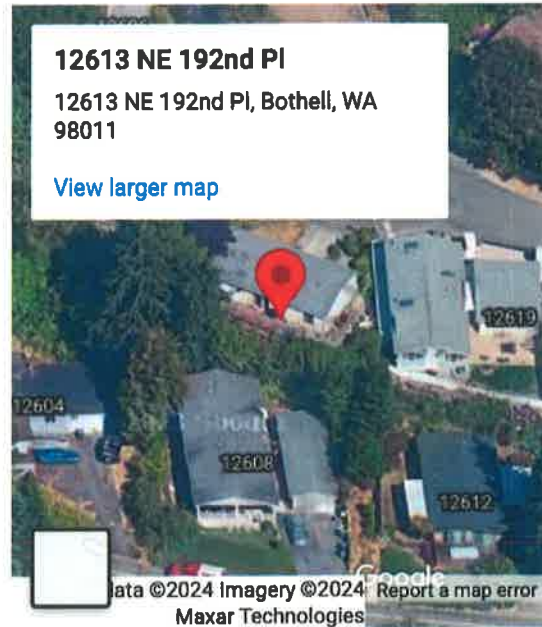

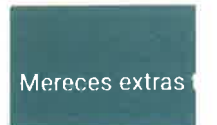
