Background

Registered voter TRENTON RAY DENNISON, DOB 1 January 2005, (the "VOTER") is registered with a residence address of 801 COMANCHE DRIVE, MOUNT VERNON WA 98273 and a status of Active. There is a separate mailing address on file for the VOTER in the Voter Registration Database ("VRDB") of P.O. Box 2126, Mount Vernon WA 98273.

History

The Washington Voter Research Project canvassed this address in April of 2024 and again on 25 August 2024. Through these contacts, the canvasser learned the VOTER did not reside at the residence address listed in the VRDB.

Affidavit

On 25 August 2024, an affidavit was collected from affiant ELISEO RONCES, certifying that the VOTER does not reside at the address.

Letter(s)

On 30 April 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form. A copy of the letter was mailed to the separate address on file in the VRDB.

Envelope

On or about 19 May 2024, the letter to the residence address in the VRDB was returned to me marked "Return To Sender – Unclaimed – Unable to Forward".

Data Searches

No data on the VOTER was returnable from this source, and a telephone number with a 360-area code could not be identified. This may be attributable to the VOTER's age.

No data on the VOTER was returnable from this source, and a telephone number with a 360-area code could not be identified. This may be attributable to the VOTER's age.

Source 3: Skagit County Property Search https://www.skagitcounty.net/search/propertym

A Skagit County Property Search conducted on 25 August 2024 shows that there is no real property in Skagit County owned in the name Trenton Dennison.

Source 4: Washington State Secretary of State https://voter.votewa.gov/

As of 1 August 2024, the Washington State Secretary of State website (containing voter registration data of Washington State registered voters) shows Trenton Ray Dennison with a birthyear of 2005 with a residence address of 801 Comanche Drive, Mount Vernon WA with no voting history.

The VoteRef website, containing the voter registration databases of at least 30 states, shows no other voters registered with the name Trenton Ray Dennison having a birthdate of 1 January 2005.

Conclusion

An affidavit was obtained attesting that TRENTON RAY DENNISON does not currently reside at 801 COMOANCHE DRIVE, MOUNT VERNON WA. The data indicates that the voter does not own property in Skagit County, has no identifiable *landline* phone number in Skagit County, and is not registered to vote in the 30+ states covered by VoteRef. The letter to the voter posted to the residence address was returned marked "Return To Sender – Unclaimed - Unable to Forward".

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed from the roll.




