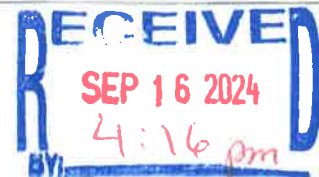

## SHANNON MARIE DOWDELL – WA1112892: Voter Challenge Summary

### Background

Registered voter SHANNON MARIE DOWDELL, DOB 24 October 1985, (the “VOTER”) is registered with a residence address of 1316 (E) SKAGIT STREET, MOUNT VERNON WA 98274 and a status of Active. There is a separate mailing address on file for the VOTER in the Voter Registration Database (“VRDB”) 1037 NE 65<sup>th</sup> Street #80276, Seattle WA 98115.

### History

The Washington Voter Research Project canvassed this address on 9 July 2024. At the time, the canvasser understood the VOTER was not residing at the residence address listed in the VRDB.

### Letter(s)

On 19 August 2024, I mailed a letter via USPS Certified Mail (Return Receipt Requested) to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form. A copy of the letter was also sent to the separate address on file in the VRDB.

### Envelope

On or about 20 August 2024, the Return Receipt for the letter to the residence address in the VRDB was returned to me signed by someone other than the VOTER, marked as “agent.”

### Data Searches

Data obtained from this source on 24 August 2024 shows a Shannon Dowdell with an age consistent with the birthyear listed in the VRDB at the address of 8771 Rooks Park Circle Apt 426, Tampa FL 33619. There are multiple addresses in Washington state, including the residence address listed in the VRDB. There is no *landline* phone number with a 360-area code.

#### Source 2: Cyber Background Checks <https://www.cyberbackgroundchecks.com/>

Data obtained from this source on 24 August 2024 shows a Shannon Dowdell with an age consistent with the birthyear listed in the VRDB at the address of 8771 Rooks Park Circle Apt 426, Tampa FL 33619. There are multiple addresses in Washington state, not including the residence address listed in the VRDB. There is no *landline* phone number with a 360-area code.

#### Source 3: Skagit County Property Search <https://www.skagitcounty.net/search/propertytm>

A Skagit County Property Search conducted on 24 August 2024 shows that there is no real property in Skagit County owned in the name Shannon Dowdell.

#### Source 4: Washington State Secretary of State <https://voter.votewa.gov/>

As of 1 August 2024, the Washington State Secretary of State website (containing voter registration data of Washington State registered voters) shows Shannon Marie Dowdell with a birthyear of 1985 with a residence address of 1316 Skagit Street, Mount Vernon WA last voted on 3 November 2020.

#### Source 5: VoteRef <https://voteref.com/>

The VoteRef website, containing the voter registration databases of at least 30 states, shows no other voters registered with the name Shannon Marie Dowdell having a birthdate of 24 October 2024.


As of 24 August 2024, the Federal Bureau of Prisons Inmate Locator shows no federal incarceration for anyone named Shannon Dowdell.

### Conclusion

A canvasser understood that SHANNON MARIE DOWDELL is not residing at 1316 (E) SKAGIT STREET, MOUNT VERNON WA. The data indicates that the voter does not own property in Skagit County, has no *landline* phone number in Skagit County, and is not registered to vote in the 30+ states covered by VoteRef. The Return Receipt for the letter to the voter posted to the residence address was returned signed by someone other than the VOTER, as “agent.”

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed from the roll.
