JUAN DANIEL GARDUNO – WA13423100: Voter Challenge Summary

Background

Registered voter JUAN DANIEL GARDUNO, DOB 12 August 1998, (the “VOTER”) is registered with a residence address of 1414 S 7TH STREET, MOUNT VERNON WA 98273 and a status of Active. There is no separate mailing address on file for the VOTER in the Voter Registration Database (“VRDB”).

History

The Washington Voter Research Project canvassed this address on 2 March 2024. At the time, the canvasser learned the VOTER did not reside at the residence address listed in the VRDB.

Affidavit

On 2 March 2024, an affidavit was collected from affiant ADRIAN MEDINA, certifying that the VOTER does not reside at the address.

Letter

On 21 March 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form.

Envelope

On or about 11 April 2024, the letter to the residence address in the VRDB was returned to me marked “Return To Sender – Unclaimed – Unable to Forward”.

Data obtained from this source on 27 April 2024 shows a Juan Garduno with an age *inconsistent* with the birthyear listed in the VRDB at the address 1414 S 7th Street, Mount Vernon WA 98273. There are three (3) additional addresses in Washington state. There is no *landline* phone number with a 360-area code.

Data obtained from this source on 27 April 2024 shows a Juan Garduno with an age *inconsistent* with the birthyear listed in the VRDB at the address 1414 S 7th Street, Mount Vernon WA 98273. There are three (3) additional addresses in Washington state. There is no *landline* phone number with a 360-area code.

A Skagit County Property Search conducted on 27 April 2024 shows a real property in Skagit County owned in the name Juan Garduno located at 22136 Little Mountain Road, Mount Vernon. However, the Washington State Secretary of State website (containing voter registration data of Washington state registered voters) shows only one “Juan Garduno” registered to vote, and that is the VOTER registered at the residence address.

As of 1 April 2024, the Washington State Secretary of State website (containing voter registration data of Washington state registered voters) shows Juan Daniel Garduno with a birthyear of 1998 with a residence address of 1414 S 7th Street, Mount Vernon WA with no voting history.


As of 27 April 2024, the Federal Bureau of Prisons Inmate Locator shows no federal incarceration for anyone named Juan Garduno.

Conclusion

An affidavit was obtained attesting that JUAN DANIEL GARDUNO does not currently reside at 1414 S 7TH STREET, MOUNT VERNON WA. The data indicates that an individual named "Juan Garduno" owns a property in Skagit County, but no one named "Juan Garduno" is registered to vote at that property. The data indicates the voter has no *landline* phone number in Skagit County and is not registered to vote in the 30+ states covered by VoteRef. The letter to the voter posted to the residence address was returned marked "Return To Sender – Unclaimed - Unable to Forward".

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed.

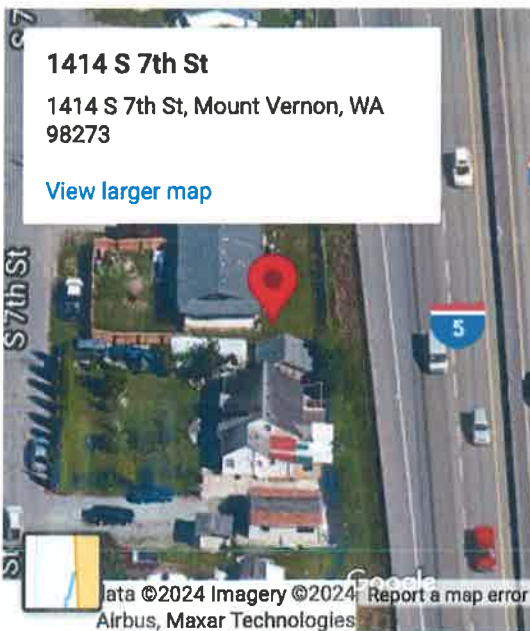

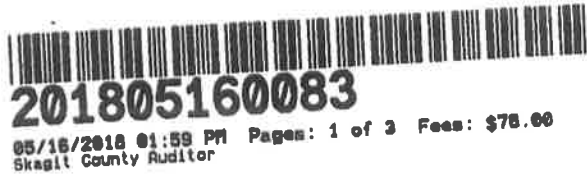

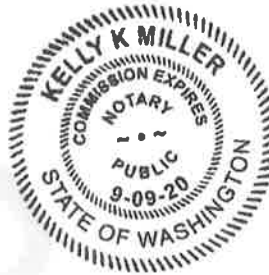
