#### Background

Registered voter PATRICIA LEE GARRITY, DOB 17 March 1965, (the "VOTER") is registered with a residence address of 3708 SENECA DR, MOUNT VERNON WA 98273 and a status of Active. There is a separate mailing address on file for the VOTER in the Voter Registration Database ("VRDB") of 823 25<sup>th</sup> Street W, Dickinson ND 58601.

#### **History**

The Washington Voter Research Project canvassed this address on 20 January 2024. At the time, the canvasser learned the VOTER did not reside at the residence address listed in the VRDB.

#### **Affidavit**

On 20 January 2024, an affidavit was collected from affiant LEVI SLIGAR, certifying that the VOTER does not reside at the address.

#### Letter(s)

On 22 January 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form. A copy of the letter was mailed to the separate address in the VRDB.

On or about 14 February 2024, the letter to the residence address in the VRDB was returned to me marked "Return To Sender – Unclaimed – Unable to Forward".

#### Conclusion




