## ANDREA DAVIES GOULD – WA8765781: Voter Challenge Summary

### Background

Registered voter ANDREA DAVIES GOULD, DOB 21 July 1980, (the “VOTER”) is registered with a residence address of 2206 E MEADOW BLVD, MOUNT VERNON WA 98273 and a status of Active. There is a separate mailing address on file for the VOTER in the Voter Registration Database (“VRDB”) of 2413 Hillside Lane, Everett WA 98203.

### History

The Washington Voter Research Project developed research information supporting a determination the VOTER did not reside at the residence address listed in the VRDB.

### Letter(s)

On 6 February 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form. A copy of the letter was mailed to the separate address on file in the VRDB.

### Envelope

On or about 27 February 2024, the letter to the residence address in the VRDB was returned to me marked “Return To Sender – Unclaimed – Unable to Forward”.

A Skagit County Property Search conducted on 22 April 2024 shows that there is no real property in Skagit County owned in the name Andrea Gould.

As of 22 April 2024, the Washington State Secretary of State website (containing voter registration data of Washington State registered voters) shows Andrea Davies Gould with a birthyear of 1980 with a residence address of 2206 E Meadow Blvd, Mount Vernon WA last voted on 2 August 2022.

#### Source 5: VoteRef <https://voteref.com/>

The VoteRef website, containing the voter registration databases of at least 30 states, shows no other voters registered with the name Andrea Davies Gould having a birthdate of 21 July 1980.


As of 22 April 2024, the Federal Bureau of Prisons Inmate Locator shows no federal incarceration for anyone named Andrea Gould.

### Conclusion

Research information was developed supporting a determination that ANDREA DAVIES GOULD does not currently reside at 2206 E MEADOW BLVD, MOUNT VERNON WA. The data indicates that the voter does not own property in Skagit County, has no *landline* phone number in Skagit County, and is not registered to vote in the 30+ states covered by VoteRef. The letter to the voter posted to the residence address was returned marked "Return To Sender – Unclaimed - Unable to Forward".

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed.
