ELIZABETH ANNE GREY – WA10142118: Voter Challenge Summary

Background

Registered voter ELIZABETH ANNE GREY, DOB 1 November 1969, (the “VOTER”) is registered with a residence address of 4627 SHANTEL STREET, MOUNT VERNON WA 98274 and a status of Active. There is a separate mailing address on file for the VOTER in the Voter Registration Database (“VRDB”) P.O.Box 2455, Mount Vernon WA 98273.

History

The Washington Voter Research Project canvassed this address on 19 May 2024. At the time, the canvasser learned the VOTER did not reside at the residence address listed in the VRDB. The canvasser spoke with the occupant, who self-identified as the VOTER’s mother.

Letter(s)

On 20 May 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form. A copy of the letter was mailed to the separate address on file in the VRDB.

Envelope

On or about 21 June 2024, the letter to the residence address in the VRDB was returned to me marked “Return To Sender – Not Deliverable As Addressed – Unable to Forward”.

There is (or was) a *landline* phone number with a 360-area code, a code incorporating Skagit County.

Data obtained from this source on 21 August 2024 shows an Elizabeth Grey with an age consistent with the birthyear listed in the VRDB at the address of P.O. Box 3563, Arlington WA 98223. There is (or was) a *landline* phone number with a 360-area code, a code incorporating Skagit County.

A Skagit County Property Search conducted on 21 August 2024 shows that there is no real property in Skagit County owned in the name Elizabeth Grey.

As of 1 August 2024, the Washington State Secretary of State website (containing voter registration data of Washington State registered voters) shows Elizabeth Anne Grey with a birthyear of 1969 with a residence address of 4627 Shantel Street, Mount Vernon WA last voted on 3 November 2020.

The VoteRef website, containing the voter registration databases of at least 30 states, shows no other voter registered with the name Elizabeth Anne Grey having a birthdate of 1 November 1969.


As of 21 August 2024, the Federal Bureau of Prisons Inmate Locator shows no federal incarceration for anyone named Elizabeth Grey.

Conclusion

A canvasser learned that ELIZABETH ANNE GREY does not currently reside at 4627 SHANTEL STREET, MOUNT VERNON WA. The data indicates that the voter does not own property in Skagit County, has (or had) a *landline* phone number with a 360-area code, and is not registered to vote in the 30+ states covered by VoteRef. The letter to the voter posted to the residence address was returned marked "Return To Sender – Not Deliverable As Addressed - Unable to Forward".

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed from the roll.

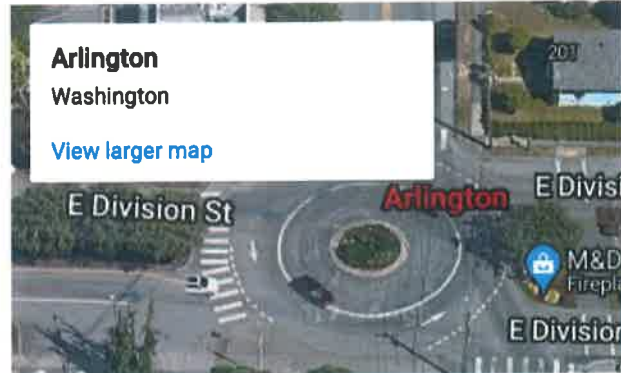

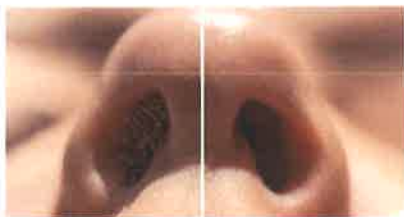
