DAVID WAYBE HENRY - WA10575754: Voter Challenge Summary

Background

Registered voter DAVID WAYNE HENRY, DOB 8 February 1983, (the "VOTER") is registered with a residence address of 1510 S 7TH STREET, MOUNT VERNON WA 98273 and a status of Active. There is a separate mailing address on file for the VOTER in the Voter Registration Database ("VRDB") of 8080 Harborview Road TRL M216, Blaine WA 98230.

History

The Washington Voter Research Project canvassed this address on 9 June 2024. At the time, the canvasser learned the VOTER did not reside at the residence address listed in the VRDB. The resident at the address self-identified as the VOTER's mother, who indicated he was not residing at the address.

Letter(s)

On 10 June 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form. A copy of the letter was mailed to the separate address in the VRDB.

Envelope

On or about 14 June 2024, the letter to the residence address in the VRDB was returned to me marked "Return To Sender – Not Deliverable As Addressed – Unable to Forward".

Data obtained from this source on 20 June 2024 shows a David Henry with an age consistent with the birthyear listed in the VRDB at the address of 8080 Harborview Road Trl M216, Blaine WA 98230. There appears to be *landline* phone numbers with a 360-area code, a code incorporating Skagit County.

Source 2: Cyber Background Checks https://www.cyberbackgroundchecks.com/

Data obtained from this source on 20 June 2024 shows a David Henry with an age consistent with the birthyear listed in the VRDB at the address of 8080 Harborview Road Trl M216, Blaine WA 98230. There are multiple additional addresses in Washington state, including the residence address listed in the VRDB, as well as addresses in Nebraska. There is no *landline* phone number with a 360-area code, a code incorporating Skagit County.

A Skagit County Property Search conducted on 20 June 2024 shows that there is no real property in Skagit County owned in the name David Henry.

As of 1 June 2024, the Washington State Secretary of State website (containing voter registration data of Washington State registered voters) shows David Wayne Henry with a birthyear of 1983 with a residence address of 1510 S 7th Street, Mount Vernon WA with no voting history.

The Idaho Voter Roll as at 20 June 2024, containing the voter registrations of all voters registered in the state, returns a voter registered in the name David Wayne Henry, however with an age inconsistent with the age of the VOTER as set out in the VRDB.

Conclusion

A canvasser learned that DAVID WAYNE HENRY does not currently reside at 1510 S 7TH STREET, MOUNT VERNON WA. The data indicates that the voter does not own property in Skagit County, may have (or have had) a *landline* phone number in Skagit County, and is not registered to vote in Idaho. The letter to the voter posted to the residence address was returned marked "Return To Sender – Not Deliverable As Addressed - Unable to Forward".

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed from the roll.
