## MIECHELLE JO HERRERA – WA12902396: Voter Challenge Summary

### Background

Registered voter MIECHELLE JO HERRERA, DOB 23 June 1966, (the “VOTER”) is registered with a residence address of 60984 STATE ROUTE 20, MARBLEMOUNT WA 98267 and a status of Active. There is no separate mailing address on file for the VOTER in the Voter Registration Database (“VRDB”).

### History

Through research, the Washington Voter Research Project developed evidence that the VOTER does not reside at the residence address listed in the VRDB. Amongst said research is a quit claim deed in respect of the residence address in favour of the recorded owner of the property, David Herrera, related to a dissolution of marriage to the VOTER.

### Letter

On 17 June 2024, I mailed a letter via USPS Certified Mail (Return Receipt Requested) to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form.

### Envelope

On or about 26 June 2024, the Return Receipt associated with the letter to the residence address in the VRDB was returned to me signed by an individual with the last name “Johnson” – not signed by the VOTER.

There are (or were) two *landline* phone numbers with a 360-area code, a code incorporating Skagit County.

A Skagit County Property Search conducted on 19 August 2024 shows that there is no real property in Skagit County owned in the name Michelle Herrera.

As of 1 August 2024, the Washington State Secretary of State website (containing voter registration data of Washington State registered voters) shows Michelle Jo Herrera with a birthyear of 1966 with a residence address of 60984 State Route 20, Marblemount WA last voted on 4 November 2008.

The VoteRef website, containing the voter registration databases of at least 30 states, shows no other voters registered with the name Michelle Jo Herrera having a birthdate of 23 June 1966.


As of 19 August 2024, the Federal Bureau of Prisons Inmate Locator shows no federal incarceration for anyone named Michelle Herrera.

### Conclusion

Research was developed that MIECHELLE JO HERRERA does not currently reside at 60984 STATE ROUTE 20, MARBLEMOUNT WA. The data indicates that the voter does not own property in Skagit County, has (or had) *landline* phone numbers in Skagit County, and is not registered to vote in the 30+ states covered by VoteRef. The Return Receipt for the letter to the voter posted to the residence address was returned signed not by the VOTER but by someone with the last name "Johnson."

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed from the roll.

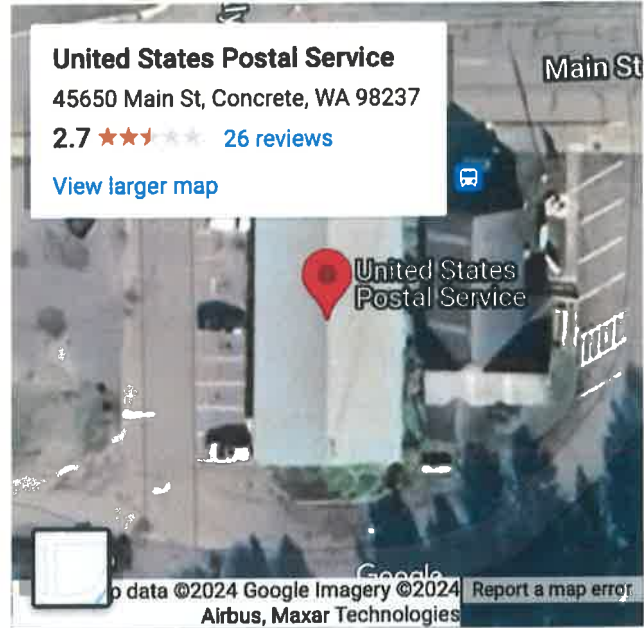
