#### TYLER BENTON HUGHES – WA12624665: Voter Challenge Summary

#### Background

Registered voter TYLER BENTON HUGHES, DOB 28 July 1969, (the "VOTER") is registered with a residence address of 1107 S 3<sup>rd</sup> ST 103, MOUNT VERNON WA 98273 and a status of Active. There is a separate mailing address on file for the VOTER in the Voter Registration Database ("VRDB") of 9212 60<sup>th</sup> Ave CT E, Puyallup WA 98371.

#### **History**

Via research, the canvasser developed evidence the VOTER did not reside at the residence address listed in the VRDB.

#### Letter

On 10 April 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form. A copy of the letter was mailed to the separate address in the VRDB.

#### Envelope

On or about 19 April 2024, the letter to the residence address in the VRDB was returned to me marked "Return To Sender – Unclaimed – Unable to Forward".

#### Conclusion

A canvasser developed evidence via research that TYLER BENTON HUGHES does not currently reside at 1107 S 3<sup>rd</sup> ST 103, MOUNT VERNON WA. The data indicates that the voter does not own property in Skagit County, has (or had) a *landline* phone number with a 360-area code, and is not registered to vote in the 30+ states covered by VoteRef. The letter to the voter posted to the residence address was returned marked "Return To Sender – Unclaimed - Unable to Forward".

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed.




