## Background

Registered voter ROSE ELLEN JENKINS, DOB 26 February 1986, (the "VOTER") is registered with a residence address of 1510 E BROADWAY, MOUNT VERNON WA 98287 and a status of Active. There is no separate mailing address on file for the VOTER in the Voter Registration Database ("VRDB").

## **History**

The Washington Voter Research Project canvassed this address on 28 April 2024. At the time, the canvasser learned the VOTER did not reside at the residence address listed in the VRDB. The canvasser spoke with the resident, who identified herself as the VOTER's mother-in-law, and learned the VOTER had moved out-of-state.

## Letter

On 30 April 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form.

## **Envelope**

On or about 24 May 2024, the letter to the residence address in the VRDB was returned to me marked "Return To Sender – Not Deliverable As Addressed – Unable to Forward".

Through the resident, who self-identified as the VOTER's mother-in-law, the canvasser learned the VOTER lives out-of-state. The data indicates that the voter does not own property in Skagit County, has (or had) a *landline* phone number with a 360-area code, and is not registered to vote in the 30+ states covered by VoteRef. The letter to the voter posted to the residence address was returned marked "Return To Sender – Not Deliverable As Addressed - Unable to Forward".

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed.




