## ROSE ELLEN JENKINS – WA10482093: Voter Challenge Summary

### Background

Registered voter ROSE ELLEN JENKINS, DOB 26 February 1986, (the “VOTER”) is registered with a residence address of 1510 E BROADWAY, MOUNT VERNON WA 98287 and a status of Active. There is no separate mailing address on file for the VOTER in the Voter Registration Database (“VRDB”).

### History

The Washington Voter Research Project canvassed this address on 28 April 2024. At the time, the canvasser learned the VOTER did not reside at the residence address listed in the VRDB. The canvasser spoke with the resident, who identified herself as the VOTER’s mother-in-law, and learned the VOTER had moved out-of-state.

### Letter

On 30 April 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form.

### Envelope

On or about 24 May 2024, the letter to the residence address in the VRDB was returned to me marked “Return To Sender – Not Deliverable As Addressed – Unable to Forward”.

Data obtained from this source on 5 June 2024 shows a Rose Jenkins with an age consistent with the birthyear listed in the VRDB at the address of 981 Pintail Court, Helena MT 59602. There is (or was) a *landline* phone number with a 360-area code, a code incorporating Skagit County.

Data obtained from this source on 5 June 2024 shows a Rose Jenkins with an age consistent with the birthyear listed in the VRDB at the address of 981 Pintail Court, Helena MT 59602. There is (or was) a *landline* phone number with a 360-area code, a code incorporating Skagit County.

A Skagit County Property Search conducted on 5 June 2024 shows that there is no real property in Skagit County owned in the name Rose Jenkins.

#### Source 4: Washington State Secretary of State <https://voter.votewa.gov/>

As of 1 June 2024, the Washington State Secretary of State website (containing voter registration data of Washington State registered voters) shows Rose Ellen Jenkins with a birthyear of 1986 with a residence address of 1510 E Broadway, Mount Vernon WA last voted on 9 February 2021.

#### Source 5: VoteRef <https://voteref.com/>

The VoteRef website, containing the voter registration databases of at least 30 states, shows a voter registered with the name Rose Ellen Jenkins having a birthdate of 26 February 1986 in both Washington state and Montana.


As of 5 June 2024, the Federal Bureau of Prisons Inmate Locator shows no federal incarceration for anyone named Rose Jenkins.

### Conclusion

A canvasser learned that ROSE ELLEN JENKINS does not currently reside at 1510 E BROADWAY, MOUNT VERNON WA. Through the resident, who self-identified as the VOTER's mother-in-law, the canvasser learned the VOTER lives out-of-state. The data indicates that the voter does not own property in Skagit County, has (or had) a *landline* phone number with a 360-area code, and is not registered to vote in the 30+ states covered by VoteRef. The letter to the voter posted to the residence address was returned marked "Return To Sender – Not Deliverable As Addressed - Unable to Forward".

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed.

(A) Sent a letter with return service requested to the challenged voter's residential address provided, and to the challenged voter's mailing address, if provided;
