TRAVIS LEON JENNINGS – WA13322681: Voter Challenge Summary

Background

Registered voter TRAVIS LEON JENNINGS, DOB 14 September 1976, (the “VOTER”) is registered with a residence address of 738 HUMPHREYS PLACE, BURLINGTON WA and a status of Active. There is no separate mailing address on file for the VOTER in the Voter Registration Database (“VRDB”).

History

The Washington Voter Research Project canvassed this address on 15 April 2024. At the time, the canvasser learned the VOTER did not reside at the residence address listed in the VRDB. The resident advised the canvasser that the VOTER is a relative who lives in California.

Letter

On 30 May 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form.

Envelope

On or about 1 June 2024, the letter to the residence address in the VRDB was “left with an individual at the address” according to the US Postal Service.

Data obtained from this source on 4 June 2024 shows a Travis Jennings with an age consistent with the birthyear listed in the VRDB at the address of 4774 Parkwest Drive, San Jose CA 95130. There is one address in Washington state (not the residence address listed in the VRDB) as well as multiple addresses in California. There is no *landline* phone number with a 360-area code.

A Skagit County Property Search conducted on 4 June 2024 shows that there is no real property in Skagit County owned in the name Travis Jennings.

As of 1 June 2024, the Washington State Secretary of State website (containing voter registration data of Washington State registered voters) shows Travis Leon Jennings with a birthyear of 1976 with a residence address of 738 Humphreys Place, Burlington WA with no voting history.


As of 4 June 2024, the Federal Bureau of Prisons Inmate Locator shows no federal incarceration for anyone named Travis Jennings.

Conclusion

A canvasser learned that TRAVIS LEON JENNINGS does not currently reside at 738 HUMPHREYS PLACE, BURLINGTON WA. The canvasser was advised by the resident at the residence address that the VOTER is a relative who lives in California. The data indicates that the voter does not own property in Skagit County, has no *landline* phone number in Skagit County, and is not registered to vote in the 30+ states covered by VoteRef.

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed.

- (ii) Submit evidence that he or she exercised due diligence to verify that the challenged voter does not reside at the address provided and to attempt to contact the challenged voter to learn the challenged voter's actual residence, including that the challenger personally:

(A) Sent a letter with return service requested to the challenged voter's residential address provided, and to the challenged voter's mailing address, if provided;

Knowingly providing false information about yourself or your qualifications for voter registration is a class C felony punishable by imprisonment for up to five years, a fine of up to \$10,000, or both.

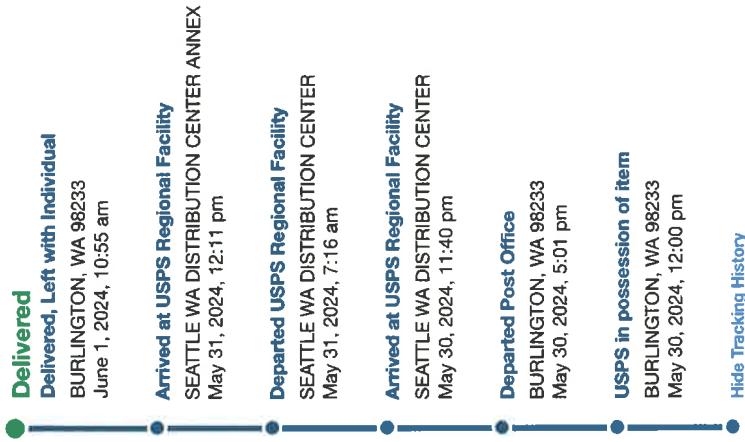

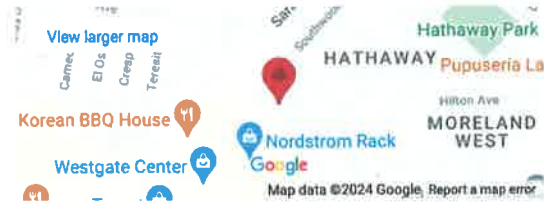
