Background

Registered voter ELIZABETH ELLEN JONES, DOB 21 September 1971, (the "VOTER") is registered with a residence address of 123 SHANTEL ST, MOUNT VERNON WA 98274 and a status of Active. There is a separate mailing address on file for the VOTER in the Voter Registration Database ("VRDB") of P.O Box 284, Mount Vernon WA 98273.

History

The Washington Voter Research Project canvassed this address on 10 February 2024. At the time, the canvasser learned the VOTER did not reside at the residence address listed in the VRDB.

Affidavit

On 10 February 2024, an affidavit was collected from affiant KEVIN WADE, certifying that the VOTER does not reside at the address.

Letter

On 20 February 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form. A copy of the letter was mailed to the separate address in the VRDB.

Envelope

On or about 11 March 2024, the letter to the residence address in the VRDB was returned to me marked "Return To Sender – Unclaimed – Unable to Forward".

A Skagit County Property Search conducted on 9 April 2024 shows there is real property in Skagit County owned in the name Elizabeth M. Jones and in the name Elizabeth A. Jones. There is an Elizabeth Margaret Jones (Voter ID#4125864) registered to vote at an address in Mount Vernon who holds title with her husband on the deed for a Mount Vernon property. There is an Elizabeth A. Jones (Voter ID#4128724) registered to vote at an address in Mount Vernon who holds title on the deed for a Mount Vernon parcel. There is no real property in Skagit County otherwise owned in the name Elizabeth Jones, Elizabeth E. Jones or Elizabeth Ellen Jones.

As of 1 April 2024, the Washington State Secretary of State website (containing voter registration data of Washington State registered voters) shows Elizabeth Ellen Jones with a birthyear of 1971 with a residence address of 123 Shantel St, Mount Vernon WA last voted on 8 November 2016.

The VoteRef website, containing the voter registration databases of at least 30 states, shows no other voters registered with the name Elizabeth Ellen Jones having a birthdate of 21 September 1971.

Conclusion

An affidavit was obtained attesting that ELIZABETH ELLEN JONES does not currently reside at 123 SHANTEL ST, MOUNT VERNON WA. The data indicates that the voter does not own property in Skagit County, has (or had) *landline* phone numbers with a 360-area code, and is not registered to vote in the 30+ states covered by VoteRef. The letter to the voter posted to the residence address was returned marked "Return To Sender – Unclaimed - Unable to Forward".

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed from the roll.

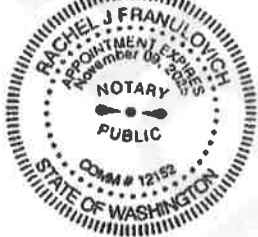
