CHARLES SCOTT KRAUCH – WA4134231: Voter Challenge Summary

Background

Registered voter CHARLES SCOTT KRAUCH, DOB 23 August 1959, (the “VOTER”) is registered with a residence address of 7291 N SUPERIOR AVE, CONCRETE WA 98237 and a status of Active. There is a separate mailing address on file for the VOTER in the Voter Registration Database (“VRDB”) of P.O. Box 264, Marblemount WA 98267.

Voter Status

A review of the November 2020 and 2022 federal general election Ballot Status Report data from the Washington Secretary of State showing the date ballots were sent to voters reflects that the VOTER was not sent early (UOCAVA) ballots, rather the VOTER was sent ballots at the same time as voters in the general registered population.

History

The Washington Voter Research Project canvassed this address on 24 March 2024. At the time, the canvasser learned the VOTER did not reside at the residence address listed in the VRDB.

Affidavit

On 24 March 2024, an affidavit was collected from affiant VALERIE HAMILTON, certifying that the VOTER does not reside at the address.

Letter(s)

On 26 March 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form. A copy of the letter was sent to the separate address on file in the VRDB.

Envelope

On or about 1 April 2024, the letter to the residence address in the VRDB was returned to me marked “Return To Sender – No Mail Receptacle – Unable to Forward”.

Data Searches

Data obtained from this source on 19 August 2024 shows a Charles Krauch with an age consistent with the birthyear listed in the VRDB at the address of 63102 S Cascade Rd, Marblemount WA 98267. There are multiple additional addresses in Washington state, none including the residence address listed in the VRDB. There is (or was) a *landline* phone number with a 360-area code, a code incorporating Skagit County.

Data obtained from this source on 19 August 2024 shows a Charles Krauch with an age consistent with the birthyear listed in the VRDB at the address of 63102 S Cascade Rd, Marblemount WA 98267. There are multiple additional addresses in Washington state, none including the residence address listed in the VRDB. There is (or was) a *landline* phone number with a 360-area code, a code incorporating Skagit County.

CHARLES SCOTT KRAUCH – WA4134231: Voter Challenge Summary

Source 3: Skagit County Property Search <https://www.skagitcounty.net/search/property.m>

A Skagit County Property Search conducted on 20 August 2024 shows that there is a real property in Skagit County owned in the name Charles S. Krauch Jr. The suffix "Jr." is not included in the VRDB in relation to the VOTER. A search of the VRDB as of 1 August 2024 shows only one voter named "Charles Krauch." Although county property records do not include the DOB of a given property owner, on balance of probabilities, it is likely the property owner and the VOTER are the same individual. It is notable the return address for the deed of the property is the same post office box listed as the VOTER's separate mailing address in the VRDB.

As of 1 August 2024, the Washington State Secretary of State website (containing voter registration data of Washington State registered voters) shows Charles Scott Krauch with a birthyear of 1959 with a residence address of 7291 N Superior Ave, Concrete WA last voted on 8 November 2022.

The VoteRef website, containing the voter registration databases of at least 30 states, shows no other voters registered with the name Charles Scott Krauch having a birthdate of 23 August 1959.

As of 20 August 2024, the Skagit County Jail Roster search shows no current inmates with the name of Charles Krauch.

Conclusion

An affidavit was obtained attesting that CHARLES SCOTT KRAUCH does not currently reside at 7291 N SUPERIOR AVENUE, CONCRETE WA. The data indicates that the voter likely owns a property in Skagit County, has (or had) a *landline* phone number in Skagit County, and is not registered to vote in the 30+ states covered by VoteRef. The letter to the voter posted to the residence address was returned marked "Return To Sender – No Mail Receptacle - Unable to Forward".

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed from the roll.

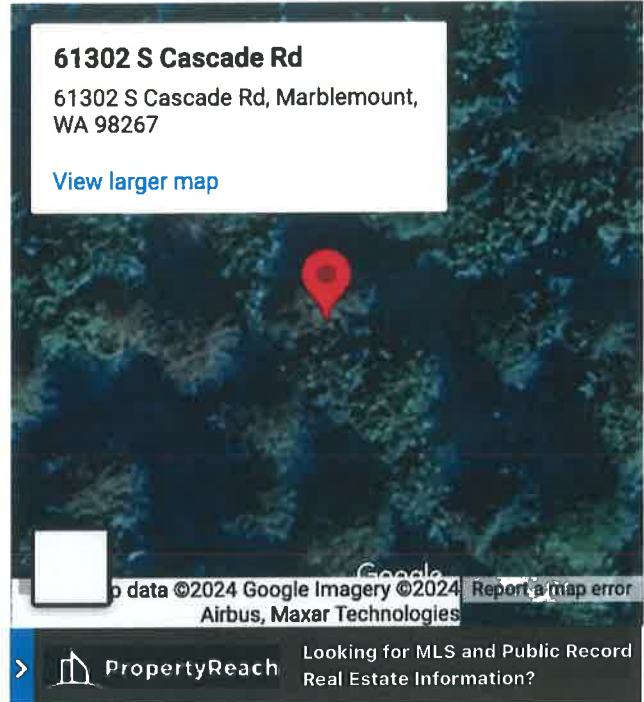

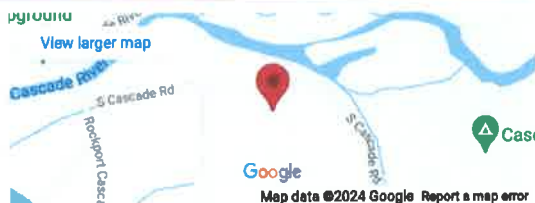
