GENEVIEVE LYNN KREIE – WA3850184: Voter Challenge Summary

Background

Registered voter GENEVIEVE LYNN KREIE, DOB 26 March 1946, (the “VOTER”) is registered with a residence address of 1009 PARKSIDE TERRACE, MOUNT VERNON WA 98273 and a status of Active. There is no separate mailing address on file for the VOTER in the Voter Registration Database (“VRDB”).

History

The Washington Voter Research Project canvassed this address on 29 May 2024. At the time, the canvasser learned the VOTER did not reside at the residence address listed in the VRDB. The residence was vacant and under renovation and repair. A conversation with the next-door neighbor in Unit 1015 confirmed the VOTER was no longer present at the residence address.

Letter

On 30 May 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form.

Envelope

On or about 20 June 2024, data from the US Postal Service indicates the residence address is “vacant” and the letter to the residence address in the VRDB was “unclaimed” and being returned.

Data obtained from this source on 4 June 2024 shows a Genevieve Kreie with an age consistent with the birthyear listed in the VRDB at the residence address listed in the VRDB as “deceased.” There are multiple additional addresses in Washington state. There are (or were) *landline* phone numbers with a 360-area code, a code incorporating Skagit County.

Data obtained from this source on 4 June 2024 shows a Genevieve Kreie at the residence address listed in the VRDB as “deceased.” There are multiple additional addresses in Washington state and addresses in Iowa. There are (or were) *landline* phone numbers with a 360-area code, a code incorporating Skagit County.

A Skagit County Property Search conducted on 4 June 2024 shows that there is no real property in Skagit County owned in the name Genevieve Kreie.

As of 1 June 2024, the Washington State Secretary of State website (containing voter registration data of Washington State registered voters) shows Genevieve Lynn Kreie with a birthyear of 1946 with a residence address of 1009 Parkside Terrace, Mount Vernon WA 98273 last voted on 3 November 2009.

The VoteRef website, containing the voter registration databases of at least 30 states, shows no other voters registered with the name Genevieve Lynn Kreie having a birthdate of 26 March 1946.


As of 4 June 2024, the Federal Bureau of Prisons Inmate Locator shows no federal incarceration for anyone named Genevieve Kreie.

Conclusion

A canvasser learned that GENEVIEVE LYNN KREIE does not currently reside at 1009 PARKSIDE TERRACE, MOUNT VERNON WA. The data indicates that the voter does not own property in Skagit County, has (or had) *landline* phone numbers in Skagit County, and is not registered to vote in the 30+ states covered by VoteRef. The letter to the voter posted to the residence address yielded data from the US Postal Service that it is vacant. The letter was identified as unclaimed and returned. Finally, there is some data indicating the VOTER may be deceased.

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed.

(A) Sent a letter with return service requested to the challenged voter's residential address provided, and to the challenged voter's mailing address, if provided;
