## SURAJ KUMAR – WA13351905: Voter Challenge Summary

### Background

Registered voter SURAJ KUMAR, DOB 5 December 1986, (the "VOTER") is registered with a residence address of 814 W DIVISION STREET, MOUNT VERNON WA 98273 and a status of Active. There is a separate mailing address on file for the VOTER in the Voter Registration Database ("VRDB") of PO Box 5395, Kent WA 98064.

### History

The Washington Voter Research Project canvassed this address on 9 June 2024. At the time, the canvasser learned that the residence address is in fact a commercial business premise and not a residence.

### Letter(s)

On 10 June 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form. A copy of the letter was sent to the separate mailing address on file in the VRDB.

### Envelope(s)

On or about 11 June 2024, the letter to the residence address in the VRDB was "Left With Individual" per the US Postal Service. On or about 12 June 2024, the letter to the separate mailing address was delivered per the US Postal Service.

### Data Searches

#### Source 1: Search People Free <https://www.searchpeoplefree.com/>

Data obtained from this source on 18 August 2024 shows a Suraj Kumar with an age consistent with the birthyear listed in the VRDB at the address of 128 Heritage Place Apt 216, Burlington WA 98233. There are additional addresses in Washington state, not including the residence address listed in the VRDB. There is no *landline* phone number with a 360-area code.

#### Source 2: Cyber Background Checks <https://www.cyberbackgroundchecks.com/>

No results could be obtained from this source.

#### Source 3: Skagit County Property Search <https://www.skagitcounty.net/search/property>

A Skagit County Property Search conducted on 18 August 2024 shows that there is no real property in Skagit County owned in the name Suraj Kumar.

#### Source 4: Washington State Secretary of State <https://voter.votewa.gov/>

As of 1 August 2024, the Washington State Secretary of State website (containing voter registration data of Washington State registered voters) shows Suraj Kumar with a birthyear of 1986 with a residence address of 814 W Division Street, Mount Vernon WA with no voting history.

#### Source 5: VoteRef <https://voteref.com/>

The VoteRef website, containing the voter registration databases of at least 30 states, shows two (2) voters registered with the name Suraj Kumar: one in Renton, Washington with a status of "Inactive" (no birthdate/birthyear data is available) and one in Washington, D.C. (no birthdate/birthyear data is available).


As of 18 August 2024, the Federal Bureau of Prisons Inmate Locator shows no federal incarceration for anyone named Suraj Kumar.

### Conclusion

A canvasser learned that the residence address is in fact a commercial business premise. The data indicates that the voter does not own property in Skagit County and has no *landline* phone number in Skagit County. There is at least one voter registered to vote in the 30+ states covered by VoteRef, namely a Suraj Kumar registered in Washington, D.C., however it was not possible to verify whether this is the VOTER, as birthdate/birthyear data is not available. The letter to the voter posted to the residence address was noted by the US Postal Service as "Left With Individual." The letter to the voter posted to the separate mailing address was noted delivered.

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed from the roll.

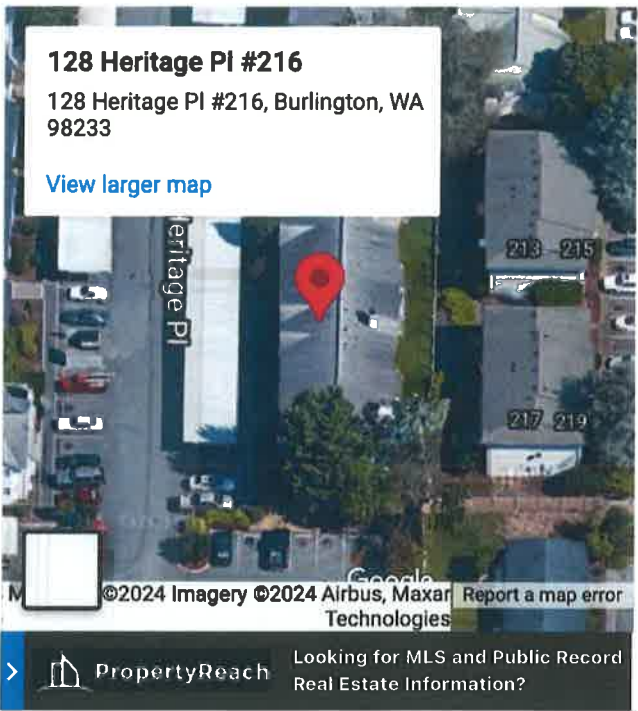

Due to the First Step Act, sentences are being reviewed and recalculated to address pending Federal Time Credit changes. As a result, an inmate's release date may not be up-to-date. Website visitors should continue to check back periodically to see if any changes have occurred.
