## CLAIRE ELIZABETH LATIMER – WA10627935: Voter Challenge Summary

### Background

Registered voter CLAIRE ELIZABETH LATIMER, DOB 13 May 1991, (the “VOTER”) is registered with a residence address of 1623 HOAG ROAD, MOUNT VERNON WA 98273 and a status of Active. There is no separate mailing address on file for the VOTER in the Voter Registration Database (“VRDB”).

### History

The Washington Voter Research Project canvassed this address on 27 January 2024. At the time, the canvasser learned the VOTER did not reside at the residence address listed in the VRDB.

### Affidavit

On 27 January 2024, an affidavit was collected from affiant AMY MUIA, certifying that the VOTER does not reside at the address.

### Letter

On 29 January 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form.

Data obtained from this source on 8 April 2024 shows a Claire Latimer with an age consistent with the birthdate listed in the VRDB at the address of 912 Rome Avenue, Durham NC 27701. There is one (1) additional address, the residence address listed in the VRDB. There are no phone numbers listed.

Data obtained from this source on 8 April 2024 shows a Claire Latimer with an age consistent with the birthdate listed in the VRDB at the address of 912 Rome Avenue, Durham NC 27701. There is one (1) additional address in North Carolina and one address in Washington State, the residence address listed in the VRDB. There are no phone numbers listed.

A Skagit County Property Search conducted on 8 April 2024 shows that there is no real property in Skagit County owned in the name Claire Latimer.

As of 1 April 2024, the Washington State Secretary of State website (containing voter registration data of Washington State registered voters) shows CLAIRE ELIZABETH LATIMER with a birthyear of 1991 with a residence address of 1623 HOAG RD, MOUNT VERNON WA last voted on 8 November 2016.

The VoteRef website, containing the voter registration databases of at least 30 states, shows Claire Elizabeth Latimer registered in Washington State having a birthdate of 13 May 1991 and also Claire Elizabeth Latimer-Dennis registered in North Carolina having a birthyear of 1991.



### Conclusion
