Background

Registered voter ELIZABETH GRACE LEWIS, DOB 10 July 1976, (the "VOTER") is registered with a residence address of 5409 N DARRK LN, BOW WA 98232 and a status of Active. There is a separate mailing address on file for the VOTER in the Voter Registration Database ("VRDB") of 5530 Chuckanut Dr Unit 42, Bow WA 98232.

History

The Washington Voter Research Project canvassed this address on 16 June 2023. At the time, the canvasser learned the VOTER did not reside at the residence address listed in the VRDB.

Affidavit

On 16 June 2023, an affidavit was collected from affiant TINA FORD, certifying that the VOTER does not reside at the address.

Letter(s)

On 28 November 2023, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form. A copy of the letter was mailed to the separate address on file in the VRDB.

On or about 3 December 2023, the letter to the residence address in the VRDB was returned to me marked "Return To Sender – Refused – Unable to Forward".

There is a voter registered in the name Elizabeth G. Lewis in New Jersey, however no birthdate/birthyear information is provided by this state. There is a voter registered in the name Elizabeth Grace Lewis in Wisconsin, however no birthdate/birthyear information is provided by this state.

Conclusion

An affidavit was obtained attesting that ELIZABETH GRACE LEWIS does not currently reside at 5409 N DARRK LN, BOW, WA. The data indicates that the voter does not own property in Skagit County, has no *landline* phone number in Skagit County. It is not possible to determine definitively whether the VOTER is registered to vote in the 30+ other states covered by VoteRef. The letter to the voter posted to the residence address was returned marked "Return To Sender – Refused - Unable to Forward".

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed.






