Background

Registered voter BEATRIZ LOPEZ, DOB 9 July 1988, (the "VOTER") is registered with a residence address of 1866 S BURLINGTON BLVD, BURLINGTON WA 98233 and a status of Active. There is a separate mailing address on file for the VOTER in the Voter Registration Database ("VRDB") of 1818 E Blackburn Rd, Mount Vernon WA 98274.

History

The Washington Voter Research Project canvassed this address on 30 December 2023. At the time, the canvasser learned that the residence address is in fact a hotel.

Letters

On 5 January 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form. A copy of the letter was mailed to the separate address on file in the VRDB.

Envelope

On or about 10 January 2024, the letter to the residence address in the VRDB was returned to me absent any specific markings.

Data obtained from this source on 9 April 2024 shows a Beatriz Lopez with an age consistent with the birthdate listed in the VRDB at the address of P.O. Box 921089, Dutch Harbor AK 99692. There are multiple additional addresses in Washington State. There is (or was) a *landline* phone number with a 360-area code, a code incorporating Skagit County. A second Beatriz Lopez with an age consistent with the birthdate listed in the VRDB was located at the address of 4723 148th NE Ave Apt DD204, Bellevue WA 98007. This listing had multiple additional addresses in Washington State, but there was no *landline* phone number with a 360-area code.

Data obtained from this source on 9 April 2024 shows a Beatriz Lopez with an age consistent with the birthdate listed in the VRDB at the address of P.O. Box 921089, Dutch Harbor AK 99692. As of 1 April 2024, the Washington State Secretary of State website (containing voter registration data of Washington State registered voters) shows Beatriz Lopez with a birthyear of 1988 with a residence address of 1866 S Burlington Blvd, Burlington WA. There is no information when the VOTER last voted.

Source 5: VoteRef https://voteref.com/

The VoteRef website, containing the voter registration databases of at least 30 states, shows multiple voters registered with the name Beatriz Lopez in New Jersey, however birthdate data is not made available by that state to the VoteRef platform. There is further a voter registered with the name Beatriz Lopez in Alaska, however birthdate data is not made available by that state to the VoteRef platform.

As of 9 April 2024, the Skagit County Jail Roster search shows no current inmates with the name of Beatriz Lopez.

Conclusion

A canvasser learned the residence address was, in fact, a hotel. The data indicates that the voter does not own property in Skagit County, may have (or may have had) a *landline* phone number with an area code incorporating Skagit County, and may registered to vote in Alaska and/or Alaska further to information contained in VoteRef. The letter to the voter posted to the residence address was returned without particularized markings.

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed from the roll.


