### Background

Registered voter JOSHUA DAVID MAKI, DOB 18 November 1991, (the "VOTER") is registered with a residence address of 2522 OLD HIGHWAY 99 S ROAD TRL 57, MOUNT VERNON WA and a status of Active. There is a separate mailing address on file for the VOTER in the Voter Registration Database ("VRDB") of 8001 21st Avenue NW, Tulalip WA 98271.

## **History**

The Washington Voter Research Project canvassed this address on 12 June 2024. At the time, the canvasser learned the VOTER did not reside at the residence address listed in the VRDB. The trailer space was observed to be empty, and a witness on site at the park indicated the trailer in space 57 had vacated some time previous.

# Letter(s)

On 14 June 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form. A copy of the letter was mailed to the separate address on file in the VRDB.

The letter to the voter posted to the residence address was returned marked "Moved Left No Address – Unable To Forward - Return To Sender".

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed from the roll.
