## JOSHUA DAVID MAKI – WA9414162: Voter Challenge Summary

### Background

Registered voter JOSHUA DAVID MAKI, DOB 18 November 1991, (the "VOTER") is registered with a residence address of 2522 OLD HIGHWAY 99 S ROAD TRL 57, MOUNT VERNON WA and a status of Active. There is a separate mailing address on file for the VOTER in the Voter Registration Database ("VRDB") of 8001 21<sup>st</sup> Avenue NW, Tulalip WA 98271.

### History

The Washington Voter Research Project canvassed this address on 12 June 2024. At the time, the canvasser learned the VOTER did not reside at the residence address listed in the VRDB. The trailer space was observed to be empty, and a witness on site at the park indicated the trailer in space 57 had vacated some time previous.

### Letter(s)

On 14 June 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form. A copy of the letter was mailed to the separate address on file in the VRDB.

### Envelope(s)

On or about 17 June 2024 the letter to the residence address in the VRDB was returned to me marked "Moved Left No Address – Unable To Forward - Return To Sender".

Data obtained from this source on 19 June 2024 shows a Joshua Maki with an age consistent with the birthyear listed in the VRDB at the address of 4201 Elm Ave Apt 115, Rapid City SD 57701. There are multiple additional addresses in Washington state, none of which is the residence address listed in the VRDB, and an address in Oregon. There is no *landline* phone number with a 360-area code.

Data obtained from this source on 19 June 2024 shows a Joshua Maki with an age consistent with the birthyear listed in the VRDB at the address of 4201 Elm Ave Apt 115, Rapid City SD 57701. There are multiple additional addresses in Washington state, none of which is the residence address listed in the VRDB, and two (2) addresses in Oregon. There is no *landline* phone number with a 360-area code.

A Skagit County Property Search conducted on 19 June 2024 shows that there is no real property in Skagit County owned in the name Joshua Maki.

As of 1 June 2024, the Washington State Secretary of State website (containing voter registration data of Washington State registered voters) shows Joshua David Maki with a birthyear of 1991 with a residence address of 2522 Old Highway 99 S Road Trl 57, Mount Vernon WA last voted on 8 November 2022.



### Conclusion

A canvasser learned JOSHUA DAVID MAKI does not currently reside at 2522 OLD HIGHWAY 99 S ROAD TRL 57, MOUNT VERNON WA. The data indicates that the voter does not own property in Skagit County, has no *landline* phone number in Skagit County, and is not registered to vote in Idaho. The letter to the voter posted to the residence address was returned marked "Moved Left No Address – Unable To Forward - Return To Sender".

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed from the roll.

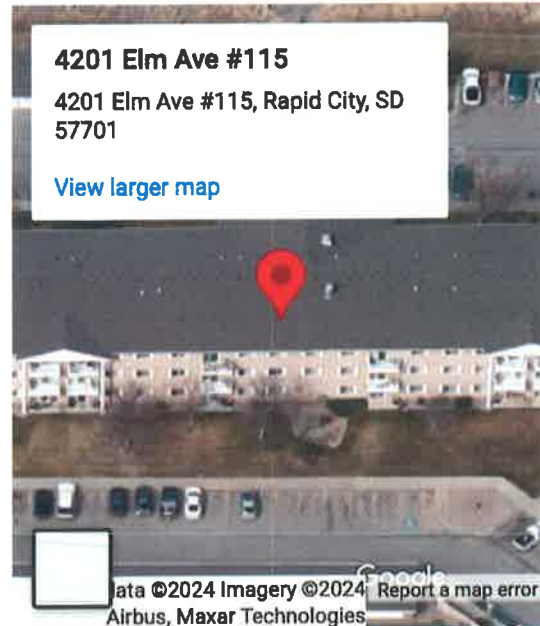

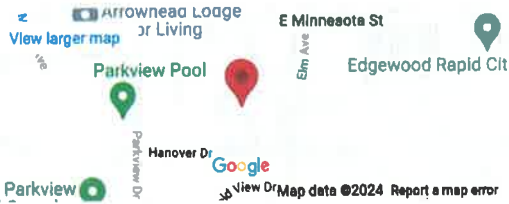

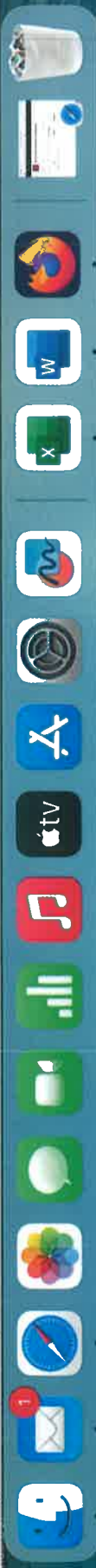
