#### KYLE M. MCINNIS – WA7965141: Voter Challenge Summary

#### **Background**

Registered voter KYLE M. MCINNIS, DOB 10 January 1989, (the "VOTER") is registered with a residence address of 321 N 30<sup>TH</sup> STREET, MOUNT VERNON WA 98273 and a status of Active. There is no separate mailing address on file for the VOTER in the Voter Registration Database ("VRDB").

#### **History**

The Washington Voter Research Project canvassed this address on 27 April 2024. At the time, the canvasser learned the VOTER did not reside at the residence address listed in the VRDB. The canvasser was advised by the resident, who identified himself as the VOTER's brother, that the VOTER lived out-of-state.

#### Letter

On 30 April 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form.

#### Envelope

On or about 4 May 2024, I received back a return receipt for the letter referenced above signed by an individual with the last name "Waite".

As of 1 June 2024, the Washington State Secretary of State website (containing voter registration data of Washington State registered voters) shows Kyle M. McInnis with a birthyear of 1989 with a residence address of 321 N 30<sup>th</sup> Street, Mount Vernon WA last voted on 6 November 2012.

The VoteRef website, containing the voter registration databases of at least 30 states, shows no other voters registered with the name Kyle M. McInnis having a birthdate of 10 January 1989.

#### Conclusion

A canvasser learned that KYLE M. MCINNIS does not currently reside at 321 N 30<sup>TH</sup> STREET, MOUNT VERNON WA and lives out-of-state. The data indicates that the voter does not own property in Skagit County, has (or had) *landline* phone numbers with a 360-area code, and is not registered to vote in the 30+ states covered by VoteRef. The return receipt for the letter to the voter posted to the residence address was returned signed by an individual with the last name "Waite," not by the VOTER.

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed.
