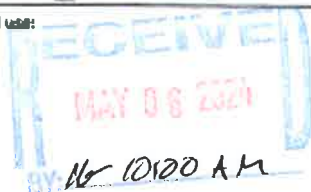

Background

Registered voter CHRISTINA NICOLE NUNES, DOB 6 February 1995, (the “VOTER”) is registered with a residence address of 3904 RIDGE WAY, MOUNT VERNON WA 98273 and a status of Active. There is a separate mailing address on file for the VOTER in the Voter Registration Database (“VRDB”) of 5568 Caden Ct, Milton FL 32571.

History

The Washington Voter Research Project developed research information supporting a determination that the VOTER did not reside at the residence address listed in the VRDB.

Letter(s)

On 29 January 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form. A copy of the letter was mailed to the separate address on file in the VRDB.

Envelope(s)

On or about 23 February 2024, the letter to the residence address in the VRDB was returned to me marked “Return To Sender – Unclaimed – Unable to Forward”. On or about 12 February 2024, the return receipt for the letter mailed to the separate address was returned to me signed and printed with the name “Christina Nunes”.

Data obtained from this source on 23 April 2024 shows a Christina Nunes with an age consistent with the birthdate listed in the VRDB at the address of 5568 Caden Ct, Milton FL 32571. There are additional addresses in Florida, Texas and Washington state, not including the residence address listed in the VRDB. There is no *landline* phone number with a 360-area code, a code incorporating Skagit County.

Data obtained from this source on 23 April 2024 shows a Christina Nunes with an age consistent with the birthdate listed in the VRDB at the address of 5568 Caden Ct, Milton FL 32571. There are additional addresses in Florida, Texas, New York and Washington state, not including the residence address listed in the VRDB. There is no *landline* phone number with a 360-area code, a code incorporating Skagit County.

A Skagit County Property Search conducted on 23 April 2024 shows that there is no real property in Skagit County owned in the name Christina Nunes.

As of 1 April 2024, the Washington State Secretary of State website (containing voter registration data of Washington State registered voters) shows Christina Nicole Nunes with a birthyear of 1995 with a residence address of 3904 Ridge Way, Mount Vernon WA last voted on 3 November 2020.

The VoteRef website, containing the voter registration databases of at least 30 states, shows no other voters registered with the name Christina Nicole Nunes having a birthdate of 6 February 1995.



Conclusion

Research information was developed supporting a determination that CHRISTINA NICOLE NUNES does not currently reside at 3904 RIDGE WAY, MOUNT VERNON WA. The data indicates that the voter does not own property in Skagit County, has no *landline* phone number in Skagit County, and is not registered to vote in the 30+ states covered by VoteRef. The letter to the voter posted to the residence address was returned marked "Return To Sender – Unclaimed - Unable to Forward".

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed from the roll.

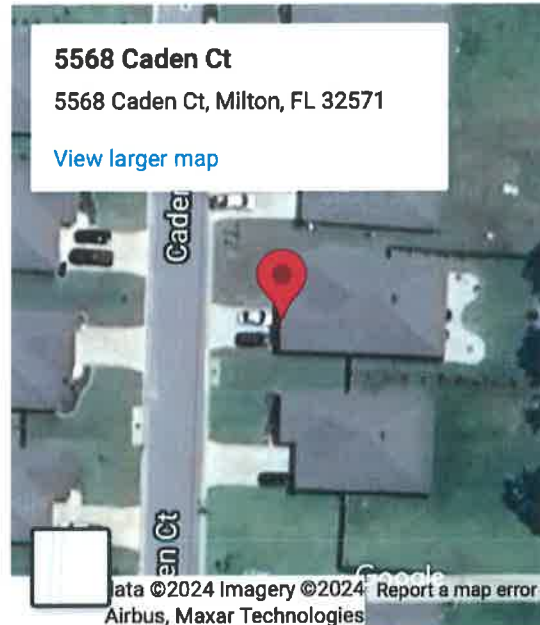
