Background

Registered voter CHRISTINA NICOLE NUNES, DOB 6 February 1995, (the "VOTER") is registered with a residence address of 3904 RIDGE WAY, MOUNT VERNON WA 98273 and a status of Active. There is a separate mailing address on file for the VOTER in the Voter Registration Database ("VRDB") of 5568 Caden Ct, Milton FL 32571.

History

The Washington Voter Research Project developed research information supporting a determination that the VOTER did not reside at the residence address listed in the VRDB.

Letter(s)

On 29 January 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form. Conclusion

Research information was developed supporting a determination that CHRISTINA NICOLE NUNES does not currently reside at 3904 RIDGE WAY, MOUNT VERNON WA. The data indicates that the voter does not own property in Skagit County, has no *landline* phone number in Skagit County, and is not registered to vote in the 30+ states covered by VoteRef. The letter to the voter posted to the residence address was returned marked "Return To Sender – Unclaimed - Unable to Forward".

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed from the roll.


