# Background

Registered voter EUGENE RAY PERSALL, DOB 21 July 1963, (the "VOTER") is registered with a residence address of 5409 N DARRK LN, BOW WA 98232 and a status of Active. There is a separate mailing address on file for the VOTER in the Voter Registration Database ("VRDB") of P.O. Box 324, Mount Vernon WA 98273.

# **History**

The Washington Voter Research Project canvassed this address on 16 June 2023. At the time, the canvasser learned the VOTER did not reside at the residence address listed in the VRDB.

#### **Affidavit**

On 16 June 2023, an affidavit was collected from affiant TINA FORD, certifying that the VOTER does not reside at the address.

# Letter(s)

On 28 November 2023, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form. A copy of the letter was mailed to the separate address on file in the VRDB.

On or about 3 December 2023, the letter to the residence address in the VRDB was returned to me marked "Return To Sender – Refused – Unable to Forward".

#### Conclusion

An affidavit was obtained attesting that EUGENE RAY PERSALL does not currently reside at 5409 N DARRK LN, BOW WA. The data indicates that the voter does not own property in Skagit County, has a *landline* phone number with a 360-area code, and is not registered to vote in the 30+ states covered by VoteRef. The letter to the voter posted to the residence address was returned marked "Return To Sender – Refused - Unable to Forward".

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed.




