JAMES CHARLES PICKERING – WA10688479: Voter Challenge Summary

Background

Registered voter JAMES CHARLES PICKERING, DOB 29 December 1961, (the "VOTER") is registered with a residence address of 2107 PACIFIC PL, MOUNT VERNON WA 98273 and a status of Active. There is no separate mailing address on file for the VOTER in the Voter Registration Database ("VRDB").

History

The Washington Voter Research Project canvassed this address on 3 February 2024. At the time, the canvasser learned the VOTER did not reside at the residence address listed in the VRDB.

Affidavit

On 3 February 2024, an affidavit was collected from affiant NICHOLE MALATIN, certifying that the VOTER does not reside at the address.

Letter

On 6 February 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form.

Conclusion

An affidavit was obtained attesting that JAMES CHARLES PICKERING does not currently reside at 2107 PACIFIC PL, MOUNT VERNON WA. The data indicates that the voter does not own property in Skagit County, has no *landline* phone number in Skagit County, and is not registered to vote in the 30+ states covered by VoteRef. The letter to the voter posted to the residence address was returned marked "Return To Sender – Not Deliverable As Addressed - Unable to Forward".

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed.




