## **Background**

Registered voter ROSS W. PILLATOS-BATES, DOB 5 September 2001, (the "VOTER") is registered with a residence address of 8519 SOUTHRIDGE PLACE, ANACORTES WA 98221 and a status of Active. There is a separate mailing address on file for the VOTER in the Voter Registration Database ("VRDB") of 2809 S. Jiovanni Place, Meridian ID 83642.

#### **History**

The Washington Voter Research Project canvassed this address on 7 July 2024. At the time, the canvasser learned the VOTER did not reside at the residence address listed in the VRDB.

#### **Affidavit**

On 7 July 2024, an affidavit was collected from affiant JANET CLEMENT, certifying that the VOTER does not reside at the address.

# Letter(s)

On 8 July 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form. A copy of the letter was mailed to the separate address on file in the VRDB.
