Background

Registered voter NILO PREUSS, DOB 21 February 1967, (the "VOTER") is registered with a residence address of 2605 RIVER VISTA LOOP, MOUNT VERNON WA 98273 and a status of Active. There is no separate mailing address on file for the VOTER in the Voter Registration Database ("VRDB").

History

The Washington Voter Research Project canvassed this address on 3 February 2024. At the time, the canvasser learned from the current resident of the residence address the VOTER did not reside at the residence address listed in the VRDB.

Letter

On 6 February 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form.

Conclusion

A canvasser learned from the current residence that NILO PREUSS does not currently reside at 2605 RIVER VISTA LOOP, MOUNT VERNON WA. The data indicates that the voter does not own property in Skagit County, has (or had) a *landline* phone number with a 360-area code, and is not registered to vote in the 30+ states covered by VoteRef. The letter to the voter posted to the residence address was returned marked "Return To Sender – Not Deliverable As Addressed - Unable to Forward".

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed.




