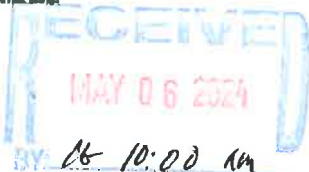

NILO PREUSS – WA12988311: Voter Challenge Summary

Background

Registered voter NILO PREUSS, DOB 21 February 1967, (the “VOTER”) is registered with a residence address of 2605 RIVER VISTA LOOP, MOUNT VERNON WA 98273 and a status of Active. There is no separate mailing address on file for the VOTER in the Voter Registration Database (“VRDB”).

History

The Washington Voter Research Project canvassed this address on 3 February 2024. At the time, the canvasser learned from the current resident of the residence address the VOTER did not reside at the residence address listed in the VRDB.

Letter

On 6 February 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form.

Envelope

On or about 10 February 2024, the letter to the residence address in the VRDB was returned to me marked “Return To Sender – Not Deliverable As Addressed – Unable to Forward”.

As of 1 April 2024, the Washington State Secretary of State website (containing voter registration data of Washington State registered voters) shows Nilo Preuss with a birthyear of 1967 with a residence address of 2605 River Vista Loop, Mount Vernon WA with no voting history.

The VoteRef website, containing the voter registration databases of at least 30 states, shows no other voters registered with the name Nilo Preuss having a birthdate of 21 February 1967.


As of 25 April 2024, the Federal Bureau of Prisons Inmate Locator shows no federal incarceration for anyone named Nilo Preuss.

Conclusion

A canvasser learned from the current residence that NILO PREUSS does not currently reside at 2605 RIVER VISTA LOOP, MOUNT VERNON WA. The data indicates that the voter does not own property in Skagit County, has (or had) a *landline* phone number with a 360-area code, and is not registered to vote in the 30+ states covered by VoteRef. The letter to the voter posted to the residence address was returned marked "Return To Sender – Not Deliverable As Addressed - Unable to Forward".

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed.

(A) Sent a letter with return service requested to the challenged voter's residential address provided, and to the challenged voter's mailing address, if provided;

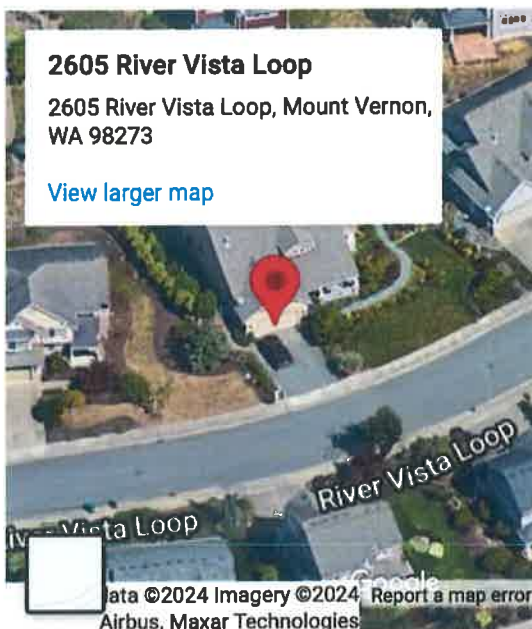
