Background

Registered voter BRIAN SCOTT RIDER, DOB 6 December 1958, (the "VOTER") is registered with a residence address of 6647 STATE ROUTE 20, ANACORTES WA 98221 and a status of Active. There is a separate mailing address on file for the VOTER in the Voter Registration Database ("VRDB") of 200 Cornet Bay Rd, Oak Harbor WA 98277.

History

The Washington Voter Research Project canvassed this address on 9 June 2024. At the time, the canvasser learned that the residence address is in fact a commercial motel at Lake Campbell.

Letter(s)

On 12 June 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form. A copy of the letter was mailed to the separate address on file in the VRDB.

Envelope

On or about 1 July 2024, the letter to the residence address in the VRDB was returned to me marked "Return To Sender – Unclaimed – Unable to Forward".

Conclusion

A canvasser learned that the residence address is in fact a commercial motel on the shore of Lake Campbell in Anacortes. The data indicates that the voter does not own property in Skagit County, has (or had) a *landline* phone number with a 360-area code, and is not registered to vote in the 30+ states covered by VoteRef. The letter to the voter posted to the residence address was returned marked "Return To Sender – Unclaimed - Unable to Forward".

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed from the roll.
