JOSIAH EDWARD GREGORY ROLLINS – WA13675903: Voter Challenge Summary

Background

Registered voter JOSIAH EDWARD GREGORY ROLLINS, DOB 4 June 2005, (the "VOTER") is registered with a residence address of 1216 S 1216 3RD STREET, MOUNT VERNON WA 98273 and a status of Active. There is a separate mailing address on file for the VOTER in the Voter Registration Database ("VRDB") of 906 E Maple Street, Arlington WA 98223.

History

The Washington Voter Research Project canvassed this address on 9 June 2024. At the time, the canvasser learned the VOTER did not reside at the residence address listed in the VRDB.

Affidavit

On 9 June 2024, an affidavit was collected from affiant FREEDOM GASSOWAY, certifying that the VOTER does not reside at the address.

Letter(s)

On 10 June 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form. A copy of the letter was mailed to the separate address on file in the VRDB.

Envelope

On or about 13 June 2024, the letter to the residence address in the VRDB was returned to me marked "Return To Sender – Forward Time Expired".



Conclusion

An affidavit was obtained attesting that JOSIAH EDWARD GREGORY ROLLINS does not currently reside at 1216 S 3RD STREET, MOUNT VERNON WA. The data indicates that the voter does not own property in Skagit County, has (or had) a *landline* phone number with a 360-area code, and is not registered to vote in the 30+ states covered by VoteRef. The letter to the voter posted to the residence address was returned marked "Return To Sender – Forward Time Expired".

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed from the roll.

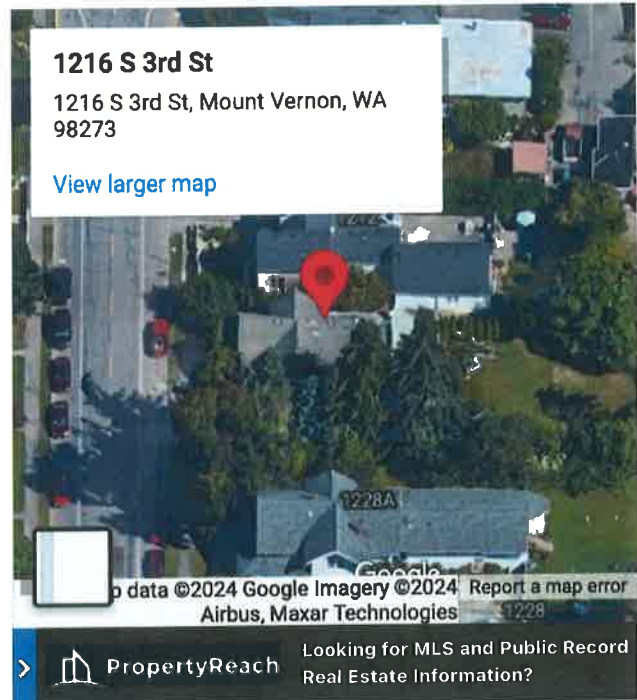
