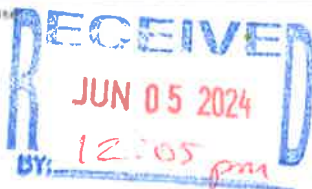

CHARLES KEN ROYCE – WA10449533: Voter Challenge Summary

Background

Registered voter CHARLES KEN ROYCE, DOB 25 October 1981, (the "VOTER") is registered with a residence address of 220 N 30TH STREET, MOUNT VERNON WA 98273 and a status of Active. There is a separate mailing address on file for the VOTER in the Voter Registration Database ("VRDB") of 10409 White Princess Avenue, Las Vegas NV 89166.

History

The Washington Voter Research Project canvassed this address on 27 April 2024. At the time, the canvasser learned the VOTER did not reside at the residence address listed in the VRDB as the residence was vacant.

Letter(s)

On 30 April 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form. A copy of the letter was sent to the separate mailing address in the VRDB.

Envelope

On or about 19 May 2024, the letter to the residence address in the VRDB was returned to me marked "Return To Sender – Unclaimed – Unable to Forward".

Data Searches

Data obtained from this source on 5 June 2024 shows a Charles Royce with an age consistent with the birthyear listed in the VRDB at the address of 10409 White Princess Ave, Las Vegas NV 89166. There are no addresses in Washington state, an address in California and several addresses in Hawaii. There is no *landline* phone number with a 360-area code.

Source 2: Cyber Background Checks <https://www.cyberbackgroundchecks.com/>

Data obtained from this source on 5 June 2024 shows a Charles Royce with an age consistent with the birthyear listed in the VRDB at the address of 10409 White Princess Ave, Las Vegas NV 89166. There is one address in Washington state (the residence address), an address in California and several addresses in Hawaii. There is no *landline* phone number with a 360-area code.

A Skagit County Property Search conducted on 5 June 2024 shows that there is no real property in Skagit County owned in the name Charles Royce.

As of 1 June 2024, the Washington State Secretary of State website (containing voter registration data of Washington State registered voters) shows Charles Ken Royce with a birthyear of 1981 with a residence address of 220 N 30th Street, Mount Vernon WA last voted on 8 November 2016.

The VoteRef website, containing the voter registration databases of at least 30 states, shows no other voters registered with the name Charles Ken Royce having a birthdate of 25 October 1981.


As of 5 June 2024, the Federal Bureau of Prisons Inmate Locator shows no federal incarceration for anyone named Charles Royce.

Conclusion

A canvasser learned that CHARLES KEN ROYCE does not currently reside at 220 N 30TH STREET, MOUNT VERNON, WA. The data indicates that the voter does not own property in Skagit County, has no *landline* phone number in Skagit County, and is not registered to vote in the 30+ states covered by VoteRef. The letter to the voter posted to the residence address was returned marked "Return To Sender – Unclaimed - Unable to Forward".

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed.
