## STANLEY J. SAINSBURY – WA4135719: Voter Challenge Summary

### Background

Registered voter STANLEY J. SAINSBURY, DOB 1 April 1924, (the "VOTER") is registered with a residence address of 909 MARIE PLACE, SEDRO-WOOLLEY WA 98284 and a status of Active. There is a separate mailing address on file for the VOTER in the Voter Registration Database ("VRDB") of P.O. Box 02592, Miami FL 33102.

### History

The Washington Voter Research Project canvassed this address on 22 August 2024. At the time, the canvasser learned the VOTER did not reside at the residence address listed in the VRDB.

### Affidavit

On 22 August 2024, an affidavit was collected from affiant CHANDA L. ROBERT, certifying that the VOTER does not reside at the address.

### Letter(s)

On 23 August 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form. A copy of the letter was mailed to the separate address on file in the VRDB.

### Envelope

On or about 28 August 2024, the letter to the residence address in the VRDB was returned to me marked "Return To Sender – Attempted – Not Known – Unable to Forward".

Data obtained from this source on 28 August 2024 shows a Stanley Sainsbury with an age consistent with the birthyear listed in the VRDB at the address of P.O. Box 25292, Miami FL 33102. There are (or were) two *landline* phone numbers with a 360-area code, a code incorporating Skagit County.

Data obtained from this source on 28 August 2024 shows a Stanley Sainsbury with an age consistent with the birthyear listed in the VRDB at the address of P.O. Box 25292, Miami FL 33102. There is one addresses in Washington state, which is the residence address listed in the VRDB, and three additional post office boxes in Florida. There are (or were) two *landline* phone numbers with a 360-area code, a code incorporating Skagit County.

A Skagit County Property Search conducted on 28 August 2024 shows that there is no real property in Skagit County owned in the name Stanley Sainsbury.

As of 1 August 2024, the Washington State Secretary of State website (containing voter registration data of Washington State registered voters) shows Stanley J. Sainsbury with a birthyear of 1924 with a residence address of 909 Marie Place, Sedro-Woolley WA last voted on 6 November 2007.

The VoteRef website, containing the voter registration databases of at least 30 states, shows no other voters registered with the name Stanley Sainsbury having a birthdate of 1 April 1924.

As of 28 August 2024, the Skagit County Jail Roster search shows no current inmates with the name of Stanley Sainsbury.


As of 28 August 2024, the Federal Bureau of Prisons Inmate Locator shows no federal incarceration for anyone named Stanley Sainsbury.

### Conclusion

An affidavit was obtained attesting that STANLEY J. SAINSBURY does not currently reside at 909 MARIE PLACE, SEDRO-WOOLLEY WA. The data indicates that the voter does not own property in Skagit County, has (or had) two *landline* phone numbers in Skagit County, and is not registered to vote in the 30+ states covered by VoteRef. It is possible the VOTER is now deceased. The letter to the voter posted to the residence address was returned marked "Return To Sender – Attempted – Not Known - Unable to Forward".

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed from the roll.

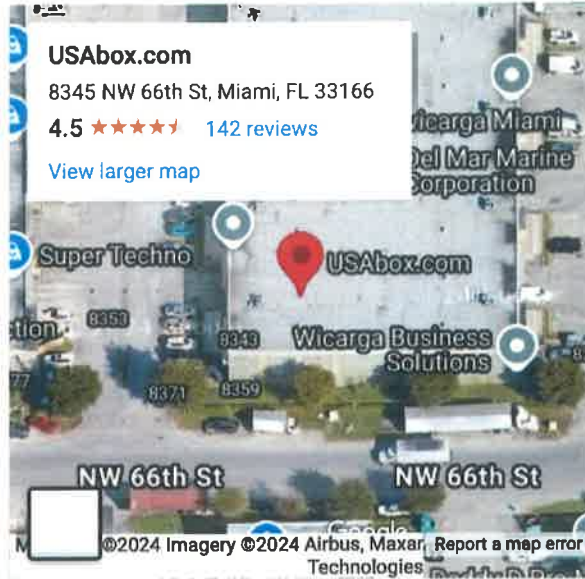
