KEITH PAUL SNIPES– WA11958091: Voter Challenge Summary

Background

Registered voter KEITH PAUL SNIPES, DOB 27 September 1981, (the “VOTER”) is registered with a residence address of 448 DALLAS STREET, MOUNT VERNON WA 98274 and a status of Active. There is no separate mailing address on file for the VOTER in the Voter Registration Database (“VRDB”).

History

The Washington Voter Research Project canvassed this address on 19 May 2024. At the time, the canvasser learned the VOTER did not reside at the residence address listed in the VRDB.

Affidavit

On 19 May 2024, an affidavit was collected from affiant JOSHUA COLLETT, certifying that the VOTER does not reside at the address.

Letter

On 20 May 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form.

Envelope

On or about 8 June 2024, the letter to the residence address in the VRDB was returned to me marked “Return To Sender – Unclaimed – Unable to Forward”.

Data obtained from this source on 10 June 2024 shows a Keith Snipes with an age consistent with the birthyear listed in the VRDB at the address of 807 W Junegrass Lane, Stansbury Park, UT 84074. There is one address in Washington state, the residence address listed in the VRDB, as well as multiple addresses in Utah, California, Arizona and Oregon and one address in Georgia. There is (or was) a *landline* phone number with a 360-area code, a code incorporating Skagit County.

Data obtained from this source on 10 June 2024 shows a Keith Snipes with an age consistent with the birthyear listed in the VRDB at the address of 448 Dallas Street, Mount Vernon WA 98274. There is one other address in Washington state, one address in Georgia and in Utah and multiple addresses in California. [There are (or were) two *landline* phone numbers with a 360-area code, a code incorporating Skagit County.

A Skagit County Property Search conducted on 10 June 2024 shows that there is no real property in Skagit County owned in the name Keith Snipes.

Source 4: Washington State Secretary of State <https://voter.votewa.gov/>

As of 1 June 2024, the Washington State Secretary of State website (containing voter registration data of Washington State registered voters) shows Keith Paul Snipes with a birthyear of 1981 with a residence address of 448 Dallas Street, Mount Vernon WA last voted on 6 November 2018.


As of 10 June 2024, the Federal Bureau of Prisons Inmate Locator shows no federal incarceration for anyone named Keith Snipes.

Conclusion

An affidavit was obtained attesting that KEITH PAUL SNIPES does not currently reside at 448 DALLAS STREET, MOUNT VERNON WA. The data indicates that the voter does not own property in Skagit County, has (or had) a *landline* phone number with a 360-area code, and is not registered to vote in the 30+ states covered by VoteRef. The letter to the voter posted to the residence address was returned marked "Return To Sender – Unclaimed - Unable to Forward".

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed.
