LINSIE BROOKE SOLORZANO – WA12978537: Voter Challenge Summary

Background

Registered voter LINSIE BROOKE SOLORZANO, DOB 7 April 1986, (the "VOTER") is registered with a residence address of 2201 N LAVENTURE ROAD APT 3, MOUNT VERNON WA 98273 and a status of Active. There is a separate mailing address on file for the VOTER in the Voter Registration Database ("VRDB") of 1500 College Way STE A #453, Mount Vernon WA 98273.

History

The Washington Voter Research Project canvassed this address on 30 June 2024. At the time, the canvasser learned the VOTER did not reside at the residence address listed in the VRDB.

Affidavit

On 30 June 2024, an affidavit was collected from affiant WENDY CULP, certifying that the VOTER does not reside at the address.

Letter(s)

On 2 July 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form. A copy of the letter was mailed to the separate address on file in the VRDB.

Envelope

On or about 6 July 2024, the letter to the residence address in the VRDB was returned to me marked "Return To Sender – Not Deliverable As Addressed – Unable to Forward".

Data obtained from this source on 21 August 2024 shows a Linsie Solorzano with an age consistent with the birthyear listed in the VRDB at the address of 6386 Lorne Green Ave Unit 103, Henderson NV 89011. There are addresses in Washington state, including the residence address listed in the VRDB, as well as multiple addresses in Texas and Nevada. There is no *landline* phone number with a 360-area code.

Data obtained from this source on 21 August 2024 shows a Linsie Solorzano with an age consistent with the birthyear listed in the VRDB at the address of 6386 Lorne Green Ave Unit 103, Henderson NV 89011. The VoteRef website, containing the voter registration databases of at least 30 states, shows a voter registered with the name Linsie Brooke Solorzano having an age consistent with the VOTER's age in the VRDB registered in Texas. The Texas registered address is consistent with an address listed for the VOTER in the address data searches set out herein.



Conclusion

An affidavit was obtained attesting that LINSIE BROOKE SOLORZANO does not currently reside at 2201 N LAVENTURE ROAD APT 3, MOUNT VERNON WA. The data indicates that the voter does not own property in Skagit County, has no *landline* phone number in Skagit County, and may be registered to vote in Texas. The letter to the voter posted to the residence address was returned marked "Return To Sender – Not Deliverable As Addressed - Unable to Forward".

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed from the roll.

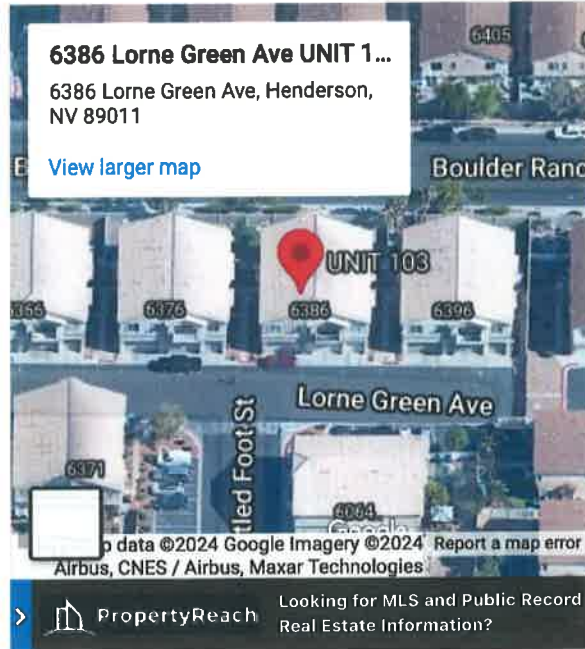
