Background

Registered voter BRONTE VICTORIA SULLIVAN DOB 18 January 1995, (the "VOTER") is registered with a residence address of 1201 DECATUR CIR, BURLINGTON WA 98233 and a status of Active. There is no separate mailing address on file for the VOTER in the Voter Registration Database ("VRDB").

History

The Washington Voter Research Project canvassed this address on 27 July 2023. At the time, the canvasser learned the VOTER did not reside at the residence address listed in the VRDB.

Affidavit

On 27 July 2023, an affidavit was collected from affiant RORY SULLIVAN, certifying that the VOTER does not reside at the address.

Letter






